To Toy Loan Redondo Beach Dianas' Youth Chairman, Mrs. Wayne Smock, has announced that the Dianas will be donating new dolls, given to them by a local toy manufacturer, to Toy Loan.

* * From a small beginning in 1938, the North Redondo Toy Loan facility has grown until it now occupies its present location in Perry Park. Almost since that small beginning, the city's junior women's club, the Dianas, have supported it as one of their charitable activities.

* * * The women built the present building for the facility in 1950 and it is now under the supervision of the Recreation Commission. The Dianas still provide part of the maintenance funds for the building.

Upon receiving a borrower's card, children are permitted to borrow a toy for one week. If neturned on time and in good condition, the child is permitted to borrow another. After the child has 15 satisfactory m arks he may borrow a wheel toy, such as a bicycle, wagon or pedal ear. After 20 satisfactory returns a girl may choose a dolt to keep and a boy something from the honor shelf. The doll must be brought back three times for a check up to make sure the new owner is being a good mother. The Dianas furnish all the honor toys.

The Dianas are affiliated with the California Federation of Women's Clubs, Marina District, Junior Membership.
