Operator Makes Her Last Call

"We rushed out of the barracks, saluted the flag, yelled, screamed, and just went sort of crazy—that is, except the Italian prisoner custodians — they just stood and looked glumly at us." Speaking was Mary Callison of 2568 Sonoma St., supervising telephone operator at Harbor General Hospital, 1000 W. Carson St. She relinquished that post Friday for retirement from 21 years

at the hospital's switchboard—and a total of 25 years and eight months county service. She worked for the Army during World War II. Mary was talking about how the staff of the Army's Port of Embarkation Hospital reacted to the radio flash that World War II had ended. It also ended the Army's interest in the hospital and her job at the switchboard. The Los Angeles Board of

Supervisors, realizing the need for a county hospital in this area, bought the facility from the Army and brought Harbor General Hospital into being. Mary joined the staff July 22, 1946, a few days after the hospital began service.

As for her retirement, Mary said she is "just going to goof off for awhile." She added that if the telephone wasn't so important in daily life, she'd "think seriously about doing without one."
