There is no federal tax on telephone calls for which the total charge is under 50 cents. The tax is limited to 10 cents if the charge is 50 cents and less than \$1.00; it is limited to 15 cents if the charge is \$1.00 and less than \$2.00; and to 20 cents for \$2.00 or more.

Rates for Appointment and Messenger calls may be obtained from Long Distance.

Station-to-Station rates of 25c or less are for an initial period of 5 minutes.

Station-to-Station rates in excess of 25c are for an initial period of 3 minutes.

All Person-to-Person rates are for an initial period of 3 minutes.

A REPORT CHARGE is applicable on Person-to-Person calls under certain conditions as outlined on page 3.
