## **RELATION OF CHAMBER OF COMMERCE TO** THE CITY TRUSTEES

#### By E. X. ANDEM President of Torrance Chamber of Commerce

Last week I stated some reasons why we should incorporate as a city: one of them is that we should MINIMIZE THE DANGER OF ANNEXATION TO LOS ANGELES. Please remember that and vote "YES." Another reason is that we are large enough and capable of SELF GOVERNMENT.

I was the man who started the "ball rolling" to incorporate and am therefore interested in the outcome of election February first, and still more interested that we have a city economically and well goverened; a city for the best interests of its citizens; a ci'y where the people will have much influence in the way the aff its are managed. In the first place I called the advisory committee of the chamber of commerce to a meeting at which we went over the subject carefully, and decided to bring the matter up in a regular meeting of the chamber, which we did. After discussion it was voted to call a mass meeting, to which the public was invited. At this mass meeting the incorporation committee was appointed which attended to all matters of detail and presented the petition to the board of supervisors who held several meetings, after advertising, at which the public had opportunity to attend. This committee worked hard and faithfully for our interests and have done its work well.

I was not one of that committee nor am I a candidate as 4 trustee, therefore my relation to the trustees will be the same as any other citizen of Torrance; but I am president of the chamber of commerce and in that capacity will do all I can for the interests of the people.

If we vote to incorporate there will be five trustees and two officers at present, who will have the direct management of the affairs of the city, but the people can help them and guide them in their work, and this can be better done through the chamber of commerce. As a city, the Torrance chamber of commerce can be a much more important and powerful body than it is now. It can take up all matters that pertain to our welfare and put them up to the Trustees and keep after them about them. They will have to recognize us and much can be accomplished through this medium. In fact the trustees will undoubtedly desire this co-operation, and harmony should prevail between the second dies. The trustees, whose services are without pay, and who have their regular business to attend to, will, no doubt, want us to bring 1.4 their attention, many things of importance and value to our welfare. We can help them in framing up the city ordinances.

Every public spirited man should belong to the Torrance chamber of commerce and have a part in the city's interests. The heads of all the industries here should also take an interest in the chamber of commerce and give it and the city, their moral and financial support. The people want this but feel that it has not been done in the past as much as it might have been done.

Preparations are being made b! er of the company was read and the directors of the Torrance Hospital to finance their association and receive memberships, and soon residents of Torrance, Lomita, Garand surrounding territory dena will have an opportunity to be come a part of one of the most worthy institutions yet promoted in this section.

Memberships are classified as follows: Life, \$100; Annual, \$5; Contributing, \$2.

For many years it has been that desire of J. S. Torrance, founder of the City of Torrance, to build a hospital, and it is he who is responsible for the promotion of the new concern, which it is hoped will be built this year. Mr. Tor-rance desires to build a hospital where the poor as well as those who can well afford to pay for hospital accomodations may be

cared for at home. An income of \$700 per month was guaranteed the new organization by the promoter, and this will cover a period of 94 years.

It is the plan to provide for at least ten beds and this equipment will run into many thousands of dollars. In order to add strength to the company it is planned to solicit memberships on the above basis and thereby have as many local people interested in this worthy institution as possible.

The Torrance Hospital will be open to all reputable physicians, and provides that the poor shall be cared for-free if necessary.
