## CALL ON SECRETARY FOR ALL DONATIONS

### TORRANCE BUSINESS MEN'S ASSOCIATION SELECT ADVISORY BOARD - DONATIONS

Thursday evening saw a representative attendance at the Business Men's Club at the White House Cafe, when several important subjects arose for decision. First came the proposition of considering communications from the J. C. McVey picture players of San Diego regarding a \$50 tax proposed by the city trustees. The secretary was asked to advise with the play house people after the committee consisting of Rappaport, Paige and Sammons had met with the trustees relative to a reduction or suspension of tax. It seems a moving picture company is liable for a state tax, a county tax, a city tax, a music tax and a government tax. The initiation fees to the Torrance Business Men's Association was fixed at \$1 and regular yearly dues \$3. All donations of whatever character will be handled through the secretary of the association. This will make it much easier for the solicitors and at the same time relieve the merchants of being pestered with numerous canvassers who come around regularly with a ticket selling contests or other means of raising money. This action was not taken with the intent of escaping or evading helping out on worthy benefits, but it will simplify matters much, and at the same time all worthy benefits will probably be more liberally supported. "Just see the secretary for my donation," will be the slogan from now on with merchants.

H. M. Tolson, A. H. Bartlett, C. J. Rahm and J. H. Fess were balloted upon and received the majority votes for the advisory board. After a lengthy discussion of Fiesta plans the meeting adjourned.

Miss Porter, director of the school, was for nine years head of the pipe organ department at Beaver College, one of the most noted and successful colleges in the east. Arrangements have been made whereby Miss Dorthea S. Lyndall, instructor in interpreted dancing, will be at the Chamber of Commerce hall in the Steffen Building at 2:30 o'clock p. m. Wednesday, at which time she will enroll or be glad to meet anyone interested in this art. Later arrangements will be made to give instruction in all the arts.

Torrance is to be congratulated on the good fortune of securing the opening of such a school whose supervision will be under the instruction of such recognized ability, and it is hoped the school will meet with much encouragement.

## ALL ALIENS MUST REGISTER

An Alien is one who was born in a foreign country (except only Porto Rico and Hawaiian Islands) and has not been naturalized in the United States. The possession of what is called "First Papers" does not constitute citizenship.

All Male Aliens between the ages of 21 and 60 years of age must register.

All aliens who fail to register before August 1, 1921, will be subject to arrest and imprisonment.

## GARBAGE ORDINANCE TO ELIMINATE FRICTION IN HANDLING REFUSE OF THE CITY

The regular adjourned meeting of the Board of Trustees was held Tuesday evening, with all trustees present. Minutes of the previous meeting were read and approved, with a few corrections.

A communication from the clerk of the Board of County Supervisors regarding the unexpended balance of the road fund was read, and it was stated that the matter had been referred to Supervisor Woodley. No word had been received from Mr. Woodley as yet.

There was also a communication read from Smart & Final Co. of Wilmington regarding the damage done to one of the city lamp posts. Messrs. Smart & Final stated that they regretted the accident and were ready to pay for the damages.

The lamp post in question is in front of Malone's drug store. Chairman Fitzhugh of the street, sewer and park committee reported that he had been in conference with the Willite Paving Co. and had received some tentative prices for the repairing of some of the streets of Torrance. The streets needing repairs at once are Arlington, Andree and Gramercy.

Joe Stone reported that he had consulted Mr. Houston of the Southern California Edison Co. regarding the rates for all night street lights. The cost to the city for the burning of the lights all night will amount to approximately \$6.00 per light per month.

The city attorney was instructed to investigate the matter of proceeding to be instigated for the city to acquire title to the streets in Torrance. At present the city holds title to only two of three streets, and if the city intends doing any improving it will be necessary for them to hold title to the streets.

The most important matter to come before the Board was that of the garbage ordinance. The city attorney has drafted an ordinance regulating the disposal of garbage from the homes and business houses in the city. Under this ordinance every person residing in a home, apartment house or rooming house must provide a metal container of more than five gallons and less than sixteen gallons capacity, the same to have handles and a metal cover. The cans must be placed in the alley within five feet of the property line, and if there is no alley the can must be placed on the curb where it will be accessible to the collector on the days of collection.

A regular schedule is to be maintained and will be published later. Violations of this ordinance carry a fine not to exceed \$300.00 or three months in the city jail, or both.

The City Fathers have looked into the matter of prices for garbage cans, and it was stated that a five gallon galvanized can may be purchased for sixty-nine cents, a six and a half gallon can for ninety-eight cents and a sixteen gallon can for \$1.98. These prices include can and cover.

The matter of establishing a night signal light to aid in police protection and try and reduce the wave of crime which has reached Torrance was brought up again, and Trustee Stone of the police, fire and light committee was instructed to have a light established over Mikleson's poolroom if satisfactory arrangements could be made. With this light established, every person having a telephone will be able to get into almost instant communication with the officer on duty.

Central will flash the light and the officer will go to the nearest phone and ascertain where and what the trouble is. The Board of Trustees should be highly commended for their action in establishing this light, and it will aid every person in trouble to get aid.

The city attorney advised the Board that it would be necessary to have a street superintendent appointed to the position at a per diem salary of \$10.00 per day for actual services. The funds for paying the salary are to be covered in the assessment for the street improvements.

There being no further business before the Board, the meeting was adjourned at ten o'clock. The next session will be the second regular meeting and will be held next Tuesday evening.
