PALOS VERDES TO HAVE MORE OIL WELLS

Lewis Again Gen. Mgr. Fourth District Meeting And Vanderlip To Wants Light on High-**Furnish Funds**

ended by about 2000 stockholders of the Palos Verdes project held at Trinity Auditorium, Los Angeles, Monday night, it was announced that Frank A. Vanderlip, international financier, is heading a group of Walf street capitalists, and that work at Palos Verdes will be speeded in.

work at False to the deduction of the astonished stockholders that the Commonwealth Trust company had been organized for the sale purpose of taking over the trusteeship from the Title Insurance and Trust com-

The Vanderlip interests, it was announced, through the new Commonwealth Trust company, stand ready to finance further test wells on the property in the event that the one now being drilled does not produce oil in commercial quantities.

Mr. Lewis exhibited a small vial of oil, which he said was the first taken from the well.

The announcement, which sent 2,000 stockholders into wild bursts of applause, means in effect that those who would hinder the development of Palos Verdes, as alleged by Mr. Lewis, now face an opponent whose capital is unlimited.

At the same time it was announced that E. G. Lewis, promoter of the project, whose withdrawal as active head of the organization was announced a month ago, will assume his former active duties.

"Not one cent of the underwriting trust funds, the money you have subscribed, has been used for any purpose," Mr. Lewis told the stockholders. "The entire expense of the underwriting, the surveys, selection maps, engineering work and other expenditures, has been borne by me, with the help of my associates, to the extent of more than \$1,000,000.

"Insead of withdrawing from this big enterprise, as the hostile interests anticipated I would do, I shall be ever ready to lend every aid and counsel in carrying this great project through to a superb consummation." Mr. Lewis said the Title Insurance and Trust company had withdrawn from the trust agreement after giving the \$900 subscribers opportualty to repudiate their subscriptions. He said that less than 100 had seen fit to do so.

A partial check revealed that 75 per cent of those attending the meeting had signed a transfer of their subscriptions from the Title Insurance and Trust company to the Commonwealth Trust company of-ficials of Palos Verdes said they believed the percentage was larger.

Among other announcements was that of the retirement of John H. Coverley as trust officer of the Title Insurance and Trust company, and his affiliation with Palos Verdes as manager; that the Vanderlip interests, who control the project,

enough money in hand, he said, to purchase 5600 acres.

The Commonwealth Trust company will have a building of its own, but until that time will function through offices in the Title Insurance and Trust building.

Jay Lawyer, attorney for the Vanderlip syndicate, is president of the new institution; Harry Lee Mortin, vice-president and general manager of the Mortgage Guarantee Co.; J. H. Coverly, former trust officer of the Title Insurance and Trust Co.; George A. Rogers, president of the Union Rock Co., all of Los Angeles; J. D. Finley, capitalist; E. W. Harden of the James B. Colgate banking firm, New York, and H. E. Benedict of the Vanderlip syndicate are interested in the new project.

Following the decision of the title company to bring the trust agreement to an end, Frank A. Vanderlip, who heads the syndicate controlling the big estate, was sent for and has been in the city for several days in conference with parties at interest, Mr. Vanderlip has so far declined to comment upon the situation, but Mr. Lewis said in his address Monday night that the "Vanderlip interests" were behind the new trust company and that every support would be accorded the project under its new management.
