

PROPOSED INCORPORATION OF MONETA

NOTICE OF ELECTION

Pursuant to a resolution adopted by the Board of Supervisors of the County of Los Angeles, State of California, on April 30, 1923, NOTICE IS HEREBY GIVEN that an election will be held on the 26th day of June, 1923, for the purpose of determining whether the territory included within the boundaries hereinafter described, being a portion of said County of Los Angeles, shall be incorporated as a municipal corporation of the sixth class, to be known as the CITY OF MONETA.

The number of inhabitants residing within the limits of the proposed corporation is 600, and the boundaries of said proposed corporation, as established by said Board of Supervisors, are described as follows:

Beginning at the southwest corner of Lot 75 of the McDonald Tract, as shown on map recorded in Book 15, pages 21 and 22, Miscellaneous Records of Los Angeles County; thence northerly in a direct line to a point in the westerly line of Lot 77, said tract, which is southeasterly 100 feet, measured at right angles from the southeasterly line of Los Angeles and Redondo Road, as shown on County Surveyor's Map No. 8075 on file in the office of the Surveyor of Los Angeles County; thence northeasterly parallel with said southeasterly line of Los Angeles and Redondo Road to a line which is parallel with and one hundred fifty feet easterly, measured at right angles, from the easterly line of Normandie Avenue (formerly an unnamed road lying easterly of and adjacent to Lots 96 to 104, inclusive, of said McDonald Tract); thence southerly along said parallel line to the northerly line of Lot 3 of the Vernell Tract as shown on map recorded in Book 21, page 133 of Maps, records of said county; thence westerly along the northerly line of said Lot 3 to the northwesterly corner thereof; thence southerly in a direct line to the southeasterly corner of Lot 26, said Vernell Tract; thence southerly in a direct line to the northeasterly corner of Lot 23 in Block A of Griffin and Kitzman Subdivision as shown on map recorded in Book 5, page 94 of Maps, records of said county; thence southerly in a direct line to the southeasterly corner of Lot 6 in Block B, said subdivision; thence southerly parallel with the easterly line of aforementioned Normandie Avenue to the easterly prolongation of the southerly line of Lot 99, said McDonald Tract; thence westerly in a direct line to the point of beginning.

At said election the voters are required to cast ballots which shall contain the words, "FOR INCORPORATION" or "AGAINST INCORPORATION," and also the

names of persons voted for to fill the various elective offices prescribed by law for municipal corporations of the sixth class, viz: the names of five persons to serve as trustees; the name of one person to serve as clerk; the name of one person to serve as treasurer; and are required to indicate the manner in which they desire to vote, by the use of rubber stamps, as prescribed by law. Such election shall be conducted in accordance with the general election law of the State of California, and shall be held within the limits of said proposed corporation, viz: at the Fire Engine House, on Eucalyptus Avenue, which is hereby fixed as the polling place where said election must be held; and the following named persons are appointed by said Board of Supervisors as the officers of said election, viz: INSPECTOR, B. W. De Hart; JUDGES, Wm. Boyd and James Steel; CLERKS, Maud Christenson, Lon Jackman and Clair M. Earl. The polls must be opened at six (6) o'clock in the morning, and must be kept open until seven (7) o'clock in the afternoon of the same day, when the polls must be closed, to-wit, on June 26th, 1923.

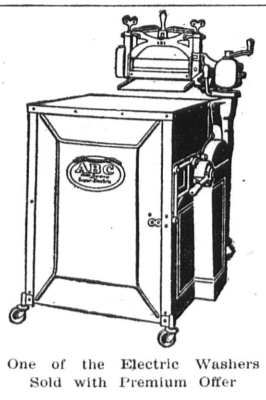
