publican in Chicago. Strawn has never participated actively in politics. He is regarded as one of the leading members of the Cook county bar, and was formerly president of the Chicago Bar association. At present he is chairman of the committee on legal education of the American Bar association. He

is a member of the law firm of Winston, Strawn & Shaw. For many years he was chief counsel for the Chicago & Alton railroad and other corporations. In 1920 he was elected president of the mail order house of Montgomery Ward & Co. He was born on a farm near Ottawa, Ill., on December 10, 1866, and educated in the public schools and admitted to the bar in 1889. He came to Chicago in 1891, where he has since been in practice. In 1897 he married Margaret Stewart of Binghamton, N. Y., and has two daughters

Mr. Strawn's firm is general counsel for the Union Stock Yards & Transit Co., Chicago Junction Railway Co., Calumet Insurance Co., Booth Fisheries Co., and solicitor for the Michigan Central railroad. Incidentally, Strawn is a former president of the United States Golf association.


