With such a water rate, the mayor also revealed the latest report of Consulting Engineer Bradshaw, which is printed in this issue.

Temporary Rates Explaining the proposed water rates under a municipally owned system, Leonard stated that during the first eight months of the first year, while construction of the plant was under way and in order to avoid assessing a property tax, it was proposed to charge \$2 for the first 1000 cubic feet and \$1.25 for additional thousands.

Permanent Rates After the preliminary eight months' construction period, the rates would be lowered to: First 800 cu. ft. \$1.00 or minimum charge

First 1000 cu. ft. \$1.25 Next 1000 cu. ft. \$1.20 Next 1000 cu. ft. \$1.15 Next 1000 cu. ft. \$1.10 Next 1000 cu. ft. \$1.05 Each additional 1000 cu. ft. \$1.00 Industrial rate, over 10,000 cu. ft. per month, per 1000 40c

City Engineer Leonard explained that the cost of pumping water at the city's wells would be about 16 cents per 1000 cubic feet as contrasted with the present wholesale rate charge by the Dominguez Water Company of 40 cents. Until the city's wells are producing and in order to show a surplus for the first year's operations, the higher rates for the first eight months of the first year would be necessary.

Leonard stated that he based his estimated rates on the expectancy of borrowing \$375,000 from the federal government, 30 per cent of which would be an outright grant, and remaining 70 per cent repaid with 4 per cent interest. That the city engineer was very conservative in his estimated, was indicated when he said he had used the 1931 consumption as a basis of his figuring.

During 1931, the present water company sold only 37,000,000 cubic feet of water in Torrance, which is less than half of the annual consumption a few years ago, and was one of the poorest years in the water company's history.

Under a municipal system, Leonard said he proposed that the city be charged 50 per fire hydrant by the water department, as against the present \$2 charge, and that it was not contemplated charging the park department any additional sum for the anticipated increased consumption when the municipal park was completed.

Second Acquittal Frees Bessone of Serious Charges

A third charge of manslaughter and a second count of driving while intoxicated, proffered against Dominico Bessone following his recent acquittal by superior court, were dismissed at a preliminary hearing in Los Angeles municipal court this week.

The new manslaughter charge followed the death of Mrs. Andrew Randazzo as the result of injuries received when her two children were fatally burned.

As in the case in which he was previously acquitted, the district attorney's office was unable to produce witnesses who would testify they smelled liquor on Bessone's breath. Also, no one had seen him drive his car, as attention had not been drawn to it until it had collided with the Randazzo machine which caught fire. Municipal Judge Harold B. Landreth dismissed the charges this week.

Henry Ford Dearborn, Mich. IN ANSWER TO A LADY'S LETTER A lady writes to say that she does not understand why an 8-cylinder car does not cost more to run than a car with fewer cylinders. She refers to my statement that our Ford V-8 develops more power on a gallon of gas than any car we have made. The use of 8-cylinders does not mean the addition of two or four extra fuel consumers. It is not, for example, a 4-cylinder engine multiplied by two. Our 8-cylinder engine takes the fuel supply of an ordinary 4-cylinder engine and divides it eight ways. And why? By reducing four large explosions into eight smaller ones, we get engine smoothness and quietness. Eight-cylinders indicate the way the gas is used, not the amount. It is just the difference between going upstairs in four long jumps or in eight ordinary steps. Two things use up gas--bad engine design and useless car weight. Besides having an engine that gets a high percentage of power out of the fuel, the Ford V-8 has a light, strong body and chassis so that no power is wasted in moving excess weight.
