Hatfield To Be In Torrance Soon

LOS ANGELES, July 19.—(Special)—George J. Hatfield, Republican of San Francisco, former United States attorney for Northern California and candidate for lieutenant-governor, will be in Torrance soon to outline his policies and plans if successful in securing election.

Hatfield has opened his Southern California headquarters in room 315, Security Building, Los Angeles. A powerful local committee is being formed to carry on the campaign in this county.

During his addresses here Hatfield has stressed the seriousness of the tax question.

"Taxation," said the candidate, "will from all indications be the main issue in the 1936 election."

While it is true that taxation seems to feature every campaign the problem is of vital importance at this time because the people voted last June to scrap the state tax system we have been using since 1911 and inaugurate a new plan of revenues for support of the state government.

Hatfield has expressed himself in opposition to the levy of an ad valorem tax on homes, farm or other property as a means of wiping out a deficit of \$31,000,000 which will face this state by the end of the current biennium of June 30, 1935.

"The next legislature," said Hatfield, "will meet in January and will have before it the necessary facts on which to base safe and sound tax legislation."

"In view of that, it would be unwise to increase the burden of taxpayers generally by levying an ad valorem tax. And we should also avoid hastily drawn or haphazard tax schemes."

Justice Monroe Is Candidate To Succeed Himself

Justice Court At Inglewood Replaces Torrance and Lomita Court

A. F. Monroe, Justice of the Peace of Inglewood township, today announced he would be a candidate to succeed himself on the bench he has occupied ever since the formation of what is now known as Inglewood township more than 20 years ago.

The August primary will be the first election held in the enlarged township which now includes, in addition to Inglewood, the townships of Redondo Beach, Gardena, La Bamba and Lomita, and has within its confines approximately 400,000 persons.

In a statement today, the Monroe for Justice Campaign Committee said:

"The incumbent, like Franklin D. Roosevelt, overcame the ravages of an early attack of infantile paralysis, and his rendered services on the bench for nearly a quarter of a century. He was admitted to the Illinois bar in 1901 and to the California bar in 1911, and has been a member continuously since that time. The laws of the state require that a Justice of the Peace of a township as large as Inglewood must be as well qualified to serve as a judge of the superior court. The enlarged township makes it imperative that whoever occupies the position of Justice of the Peace should be acquainted with the work, since it will be necessary for the incumbent to devote practically all of his time to it.

"Judge Monroe served for many years when the salary was a pittance, and only in the past few years has he been paid the present salary. His wife, a civil service employe, served as clerk for the court without pay, in the early days of the township, for more than two years.

"The enlarged township may require additional clerk hire, in which event, Judge Monroe proposes to employ qualified persons from other sections of the township, subject, of course, to the approval of the civil service commission.

"In the event of his re-election, Judge Monroe states he will be glad to hold court in various parts of the township, provided it can be legally done, and that he receives such instructions from the board of supervisors."

Civil Service Examination

The United States Civil Service Commission has announced open competitive examinations as follows:

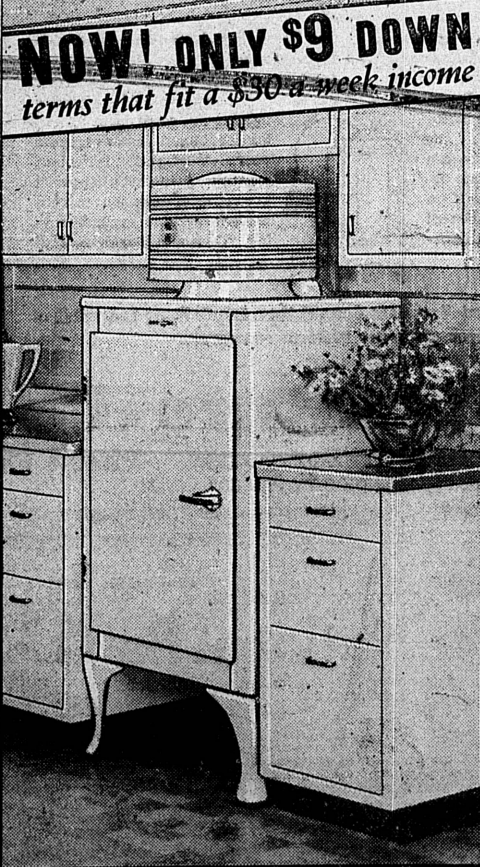

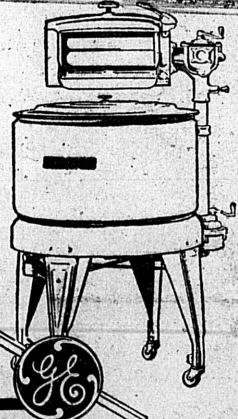

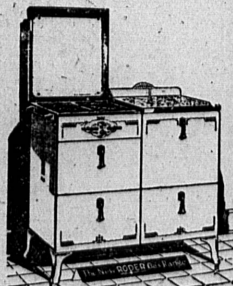
