Long Beach Man
Pleads Guilty To
Charge of Theft

Rush T. Lewis, 3733 California avenue, Long Beach, was arrested Saturday night, August 18, at Cliff House, White's Point, on a charge of petty theft and pleaded guilty in the Lomita township justice court Wednesday, August 22. Lewis plead not guilty when arraigned on Monday, and asked for a jury trial which was set for August 24, but decided to change his plea.

Lewis was accused of having taken \$71 in cash and checks from a purse belonging to a woman in the party which he was entertaining, and when Deputy Elmer Straight of the Lomita radio detail was called to the scene, he said to have been detected in the act of getting rid of a roll of bills amounting to \$50 which he had concealed about his person. Judge Esther I. Dennis ordered the money which was produced as evidence, turned over to the rightful owner and fined Lewis \$150 or 60 days in the county jail. All but \$50 of the fine was suspended and Lewis paid the balance.

Illegal Voters
Face Challenge
At Aug. Primary

Fifteen Per Cent of Sample Ballots Mailed In Long Beach Undelivered

Challenges will be made against any person appearing to request his ballot in every local precinct at the August primary election if his or her sample ballot has been returned to the registrar of voters because it had a fictitious address.

This procedure was assured by an allocation of \$10,000 made by the board of supervisors after a special committee had appeared before them charging that 300,000 persons were illegally registered for the coming August primary. The committee was headed by A. M. Wilson of Long Beach, Democratic county central committee man, who said Republican party officials had assured him that they would also request that persons claiming undeliverable sample ballots be challenged at their precincts.

Wilson called special attention to Long Beach, where he said the postmaster there was unable to deliver approximately 14,500 sample ballots out of about 92,000 mailed out to registered voters. This was 15 per cent of the number that could not be delivered because of fictitious addresses. Wilson said. About 3000 of the addresses were to vacant lots and the remainder were to houses that had been torn down or in the area within the main flood control district channel. The ratio, Wilson said, was about five Democrats to four Republicans.

George Hoy of Glendale and P. M. Abbot of the 3rd assembly district, accompanied Wilson and substantiated his claims.

According to Registrar W. M. Kerr, any person who does not live at the address given on his or her registration blank, is illegally registered. Later Kerr added: "Unless given by mistake."

Kerr exhibited to the supervisors a specially-printed card which is being sent to all precinct officers asking them to notify him of all persons whom they know have either moved away or passed away.

Judge Galbreth Is
Endorsed By Many
Prominent Leaders

Judge R. Morgan Galbreth of the Los Angeles municipal court, is sponsored for the superior court, office No. 19, by many men and women well known in this vicinity and throughout the country. Among them are Capt. John D. Fredericks, former Congressman and for 12 years Los Angeles county district attorney; Nathan Newby, attorney; Rev. Hugh K. Walker, Dr. Ross Moore, Melville T. Whitaker, Rolphie Bishop, Bidwell, Dr. Arthur L. Shellhorn and many others. Among women on his campaign committee are Mrs. Chester C. Ashley, prominent in women's activities throughout the state; Mrs. C. A. White and Mrs. Robert L. Burns.

Judge Galbreth, who has been a resident of the county 47 years, has been eight years on the municipal court and has sat in the superior court by assignment of the judicial council. In 1929, when running for re-election, he received the highest vote cast for a contested judicial office. He is a candidate at next Tuesday's primaries to succeed Superior Judge Edwin F. Hahn, retiring.

The judge is a veteran of the Spanish American war, having volunteered when just out of Occidental College. He was a member of the California National Guard for more than eight years and is a vice president of the California Volunteers Association.

Ray L. est has been shown in this contest as it is generally conceded that the Democratic nominee for Congress will carry the election in November due to the heavy Democratic registration in this district.

State Assembly One of the most heated races in the district is being waged between Democratic candidates for the state assembly with Assemblyman John T. Rawls, incumbent; George G. Aikenhead, San Pedro contractor and justice of the peace; Robert Hillier, Wilmington engineer; Edward Kossin, EPIC candidate, and former State Senator Henry E. Carter playing the leading roles. Carter is also an unopposed candidate for the state assembly on the Republican ticket. He is "hoping" to win the Democratic nomination and thus clinch the November election by running against the incumbent.

Outside of the governor contest, perhaps the most interest locally is being shown in the various candidates for Justice of the peace in the new Inglewood township comprising the present smaller townships of Inglewood, Lomita (Torrance), Redondo Beach, Gardena and La Brea. Leading candidates for Justice of the peace are Torrance C. Welch of Torrance and the only candidate from Lomita township; Judge A. F. Monroe of Inglewood, incumbent; Judge Frank Carrell of Gardena; and Henry Polglase, Redondo Beach attorney. Others in the race are Edward L. Burton, Gardena attorney; Charles T. Woodbury, Inglewood attorney, and Robert R. Weaver, Lennox attorney. While many political prognosticators expect Judge Monroe to head the list of seven candidates because of the larger population of his home community of Inglewood, few predict that he will receive a majority of the votes cast. Failing to score over half of the total votes cast in the enlarged township, Judge Monroe would be required to stand for a run-off with the second candidate on the ballot at the November election. There seems to be a general agreement among the communities of Torrance, Redondo Beach, Gardena and Lomita, that they will unite in the November election against the Inglewood candidate. If this be true, it is quite probable that the second-top man in the August primary may win the election in November. It is with this hope in mind that friends of Torrance C. Welch are rallying to his support and it is generally predicted that he will not only receive an almost solid vote from Torrance and Lomita but will also receive many votes from other communities where he is well and favorably known.

Election Returns Early reports on the trend of the election will be available through telephone reports to be made to the registrar of voters, beginning shortly after 7 p. m. next Tuesday.

Ballot boxes from precincts in this vicinity will be checked in at the Torrance city hall. The Gardena city hall is also designated as a checking-in station. As soon as returns from the various local precincts are available they will be posted at the Torrance Herald office, 1336 El Prado, and telephone inquiries to the Herald office will also be gladly answered.

3766 Registered A total of 3766 Torrance citizens will be eligible to vote at the Tuesday primary election, according to official registration figures released by City Clerk A. H. Bartlett today. In the 12 Torrance precincts there are 2018 registered Democrats, 1557 Republicans, 17 Socialists, 9 Prohibitionists, 7 Communists, and 158 who declined to state their party.

With the exception of precincts 7 and 8, which show Republican majorities of one vote each, and precinct 5 which has five more Republican registrations than Democratic, all other Torrance precincts show substantial Democratic majorities.

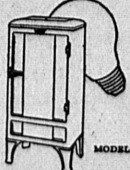
