Court Approves Sale of Assets San Pedro Bank

Long Legal Battle Terminates This Week; Inglewood Dividend Paid

Approval of the state supreme court was given this week to the sale of certain assets of the Bank of San Pedro, which has been operating under a conservatorship since the bank holiday in March, 1933, amounting to \$1,047,330. Sale was made to the Bank of America National Trust and Savings Association, by H. E. Sherer, former president of the bank and later appointed conservator. His action had been approved by the superior court of Los Angeles county, but the Standard Fisheries Company, acting for "depositors and creditors," appealed from the decision, alleging their objection to the price obtained, and claiming that State Superintendent of Banks Edward R. Rainey had no authority to sell at private sale assets of a bank taken over under the Act of 1933.

The court held that the price was the best that could be obtained, and that Rainey and Sherer acted within their rights. It permits the distribution of 70 per cent of deposits to commercial depositors and 33 per cent to savings department depositors. A 10 per cent dividend was to be paid this week to all depositors and creditors of the First Exchange Bank of Inglewood by Special Deputy E. L. Durrell, which disbursement brings the total to 40 per cent paid to commercial department and 20 per cent to savings department claimants, in addition to the payment of all state, county and municipal funds, and settlement of preferred claims.

The current payment amounts to \$63,055.91, making a total of \$709,411.77 paid out to creditors. All payments made to date have been realized from absolute liquidation of assets and no funds have been borrowed with which to pay dividends, as has been the case in many other defunct banks. It is pointed out that future payments to creditors will depend, it is said, largely upon the sale of real estate which constitutes the remaining assets.

Volunteer Workers Assist In Building New Ch. Addition

Work on the new Sunday school building, a unit of the Torrance Christian church, is progressing rapidly, according to the pastor of the church, Rev. George Elder. The sub-story will be much larger than originally planned. The army of the "Helping Hand" has completed the excavating and is now setting the forms. Friday evening, this week, beginning at 4:30 o'clock, a force of 15 to 20 men will pour the concrete. At 6:00 o'clock that evening the workers and their wives will enjoy a covered dish dinner in the social hall of the church, after which the men will resume their work. Beginning next week the carpenters will take charge of the project and soon the building will take form.

Sixth Eyegraphic Program Tonight

The sixth of the series of eyegraphic programs will be given at the Torrance Christian church, tonight, October 25, at 7:30 o'clock. The pictures and lecture will cover the conquest of Canaan and the Judges. Recent photo-slides of Palestine will be shown, according to Mrs. E. A. Baker, of Pasadena, who is in charge of the programs each Thursday evening. The program for this week will be especially interesting to the boys and girls as the evening is being promoted as "Sunday School Night." The teacher who has the largest percentage of her pupils present, based on enrollment, will receive a beautiful pressed flower from Palestine.

Local radio listeners will be interested in the announcement of the broadcasting of an authorized Christian Science lecture over KFAC, Tuesday, October 30, at 8 p. m., when Mr. Paul A. Harsch, C.S.B., of Toledo, Ohio, a member of the Board of Lecturers of The Mother Church, The First Church of Christ, Scientist, in Boston, Mass., lectures for Ninth Church of Christ, Scientist, Los Angeles.

Council Grants \$150 to Maintain Scout Troop In Torrance

Torrance Boy Scouts, through their district commissioner, W. T. Jones, petitioned the city council for an appropriation of \$125 to finance the troops through the current year, and their petition was granted Tuesday night to the extent at this time of \$150. On motion of Councilman W. T. Klusman, this sum was tendered in lieu of the entire amount, due to the fact that funds in the city treasury are low, and will not be replenished until the tax money begins to come in next month. Klusman objected to Mayor Scott R. Ludlow's instructions to the city clerk to write a letter explaining the smallness of the appropriation and assuring the Scout officials that the balance would be forthcoming later, but on a substitute motion offered by Councilman J. E. Hitchcock, the mayor was authorized to so instruct the clerk. Klusman on roll call voting in the affirmative.
