Pension Plan



"Youth for work and age for leisure," is the slogan of the old age pension plan formulated by Dr. Francis Everett Townsend, Long Beach, Calif., physician and surgeon. He proposes a \$200 monthly pension for life to each citizen of the United States over 60, with the proviso that the money must be spent in the country within 30 days after receiving it. Funds for the pension would be raised by a national sales tax.

Six Amendments To County Charter On Ballot November 6

Six proposed amendments to the Los Angeles county charter will be on every ballot in the county at the November 6 election, by action of the board of supervisors. In addition there will be one or more flood control bond issue proposals, for the flood control district which covers the southern three-fourths of the county, and Los Angeles city voters will have 14 city charter amendments to vote upon.

A majority of the votes cast in favor of any of the county or city charter amendments will pass them into laws, while a two-thirds vote is required to carry any bond issue, it was explained. The six proposed county charter amendments are as follows: First, limitation of the general county tax rate to 80 cents for general county purposes. A test suit to place doubtful provisions of the amendment before the supreme court is being planned.

Second, giving the county the power to take over municipal functions, under contracts with cities, in addition to health service, assessing and tax collecting. This would be strictly at the option of the cities, however. Third, amending the charter to provide for a department of foster care and fire warden. This department now is set up by ordinance of the board of supervisors, and the department head is appointive.

Fourth, establishing a bureau of budget and efficiency, which would assume the work of the present bureau of efficiency, which also is set up by ordinance. Fifth, establishing the department of recreation camps and playgrounds as a department. Instead of by ordinance of the board of supervisors as at present. Sixth, consolidation of the tax collector's office with the county treasurer's office, a move that has been discussed for several months, and which is declared by the supervisors to be feasible.

CHESS By A. L. PAUL

"CHESS AS YOU LIKE IT" This slogan has been adopted by the Torrance Chess Club as typifying its activities. Visitors are always most cordially welcome at the regular Monday and Thursday evening meetings in the Recreation Center, 1316 Cabrillo avenue.

One of the cleverest examples of problem composing that has come to the notice of the writer in recent times is the following: We'll grant you an hour in which to solve it: The position: AN2; 8; 7p; 8PK3; 8BK; 4P3; 2B6; 8. White to play and mate in four moves.

In the recent tournament at Leningrad, A. Bolwinnik, a fine young master to whom the entire chess world has turned its attention, won first place. This is a repetition of his victory last year. An unusual occurrence at this year's event is the fact that the next contender for the world champion title, Dr. Max Euwe, did not finish among the high prize winners.

Ever since the modern methods of conducting tournament play have been introduced, the tendency has been to restrict the participants' best efforts. Match play, therefore, should remain the best form of chess contest. This fact was best illustrated recently in a contest for the championship of Spain, held at Madrid, where Senor Galmayo, the ex-champion, finished in third place in spite of the fact that he defeated both the leaders, A. Gromer of Paris and J. Ortueta of Madrid. While these two scored 11 points apiece, Galmayo had only 10 1/2 to his credit.

A CHESS PRIMER Lesson IV. The King moves one free square in any direction. There is, however, one exception to this rule, namely, the "castling" move. This is the term used to describe an important move which may be made once in a game, under certain conditions, by the King in combination with a Rook. Provided that neither the King nor the Rook has been previously moved, that the King is not in check (attacked by an opposing piece), or has not to pass over a square which is attacked or commanded by an opposing piece, he may move either two squares to the right or two squares to the left, and at the same time the Rook may, as it were, jump over him and come to rest at his other side. When this is done in combination with the King's Rook, this is described as Castling on the King's side, or if with the Queen's Rook, as Castling on the Queen's side.

Cat Dead at 21

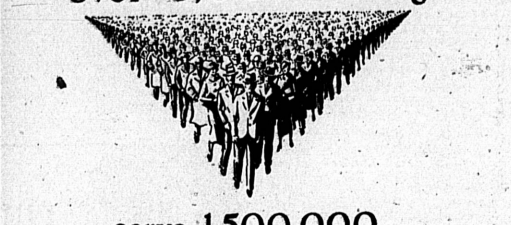
