ORDINANCE NO. 250 ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TORRANCE ESTABLISHING BOULEVARD STOPS AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

The City Council of the City of Torrance does hereby ordain as follows:

SECTION 1. That when any motor vehicle is being operated by any person, firm or corporation in any of the respective directions and upon any of the respective highways hereinafter set forth immediately prior to entering any of the respective intersections hereinafter described, it shall be unlawful for any such person, firm or corporation to operate or cause to be operated any such motor vehicle upon, along and/or across any of said respective intersections from any such respective directions and public highways without first bringing such motor vehicle to a complete stop immediately prior to entering therein, such respective directions, public highways, and intersections being more particularly described as follows:

SECTION 2. All ordinances and/or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. Any person, firm, or corporation violating any of the provisions hereof shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine not exceeding one hundred dollars, or by imprisonment for not more than fifty days, or by both such fine and imprisonment.

SECTION 4. The City Clerk shall certify to the passage and adoption of this Ordinance by the said City Council, and shall cause the same to be published by one insertion in the Torrance Herald, a weekly newspaper of general circulation, published and circulated in the City of Torrance, and thereupon and thereafter the same shall be in full force and effect.
