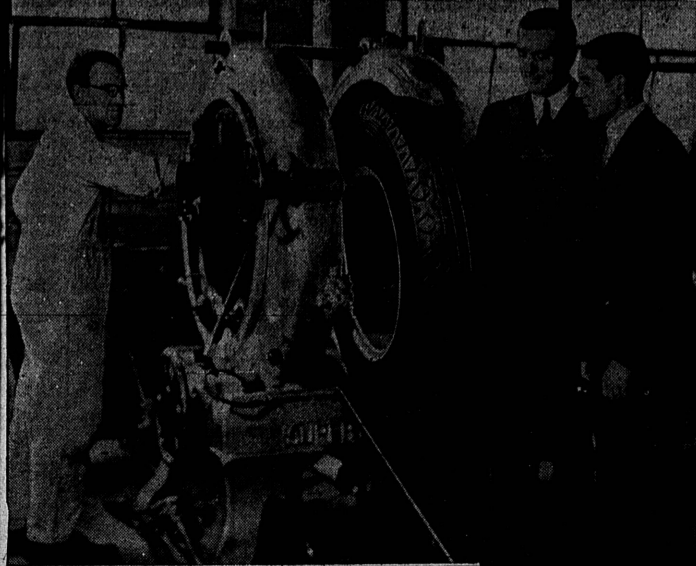


Factory Methods Used In Firestone Retreading

Southern California's newest industry was announced today by Leonard K. Firestone, Vice President and Sales Manager of the Firestone Tire and Rubber Company on the Pacific Coast. Firestone Service Stores, Inc. has established a retreading division at the Firestone Los Angeles Factory according to the young vice president. The finest retreading equipment has been installed to complete the service of our Dealers to their customers," he said. The new tire rebuilding division is already working 24 hours a day to meet the demands of car owners for this new factory controlled retreading. "The advantages to motorists and dealer in this new division are clearly evident," Mr. Firestone declared. "When the casing arrives at the factory it is carefully inspected. Only those satisfactory for retreading purposes are accepted. All tread rubber is buffed from the

tire body and it is sent to a drying room. The new tread stock is then applied in preparation for vulcanizing in the molds. "It is at this stage of retreading that great improvement is accomplished by having the new division located in the factory," Mr. Firestone said. "The nature of the cure of the tire in the mold makes a world of difference in the finished product. In this new department, we have installed factory methods of steam-control keeping temperatures at just the right degree throughout the vulcanizing process. Gauges that hold a uniform air pressure in the air bag are used to complete perfection in this important phase of retreading. "The retreads of Firestone Dealers using this new service will be absolutely finished in appearance too," the prominent young vice executive told

Bank of America Lends More Than Million Dollars

Modernization Program Meets Ready Response From Financial Institution

Modernization loans made by Bank of America in co-operation with the National Housing program total \$1,239,714. It was announced today by L. M. Giannini, senior vice president. The loans will be used to repair and modernize 3135 California homes, business properties and farm buildings with an average individual expenditure of \$392, the bank executive said. A survey of the first 1849 loans made by Bank of America for modernization shows that skilled artisans are the principal borrowers, with 273 loans, while public employes come second, with 258. Business men and clerical employees were equal claimants for third place, with 192 loans recorded for each classification. The survey showed that inside painting and redecorating work had the greatest appeal for the borrowers, indicating the intention of having this class of work performed. The 1849 borrowers included 599 who propose to paint the exteriors of their houses, 538 who contemplate new roofs, 427 who desire exterior repairs and a like number who are planning additional rooms. Heating, plumbing, cementing and lighting were among the more numerous plans reported by the borrowers.

Officers for the brotherhood were elected as follows: President, Hugh Henry; first vice president, John Young, Jr.; secretary and treasurer, Frank Perkins; program chairman, R. F. Hogue. Regular monthly meetings will be held with special ladies' nights four times each year.

HINTS FOR MOTORISTS

(The Herald today presents another group of an instructive series of questions and answers related to various phases of motor vehicle operation and operation in California. Authority for the answers is Ivan Kelo, general counsel, Automobile Club of Southern California.)

Question—Is the liability of the owner of an automobile who gives permission to another to operate his car unlimited?

Answer—Section 1714 1/2 of the Civil Code establishes the following limits of liability in any one accident: Property damage \$1000; death of or bodily injury to one person \$5000, or to two or more persons \$10,000.

Question—Must the driver of an automobile, who in making a "U" turn on the highway forces another machine off the road and into a bank causing injuries to occupants of the other car, stop and render aid even though there was no collision between the two vehicles?

Answer—Section 141 of the Vehicle Act, which sets forth the occasions in which a duty exists to stop in the event of an accident, refers to "the driver of any vehicle involved in an accident" resulting in injury or death to persons or damage to property. A proper construction of this wording would include incidents of the kind described, as well as those in which the driver of a vehicle collides with another object, as it cannot be said that the vehicle making the "U" turn was not "involved" in the accident. Aid should be rendered and the other duties required by Section 141 should be fulfilled.

Question—A judgment was rendered against me and was not satisfied within 15 days after it became final and I was required to surrender my operator's license to the Department of Motor Vehicles. Thereafter the judgment was satisfied and I filed an insurance certificate and application for the resumption of the license. The license was resumed in a restricted form. For how long a period of time will I be required to operate my car under this restriction?

Answer—The provisions of Section 73-g of the California Vehicle Act do not limit the time in which proof of ability to respond in damages must be made. Neither is there any limitation of time in Section 36 1/2 and 36 3/4 of the California Vehicle Act providing the method for filing proof of ability to respond in damages. It will, therefore, be necessary to
