ORDINANCE NO. 261

AN ORDINANCE OF THE CITY OF TORRANCE REGULATING THE PLAYING OF GAMES OF SKILL, PRESCRIBING A LICENSE THEREFOR, REGULATING THE MANAGEMENT AND CONDUCT OF GAMES WHERE SUCH GAMES ARE PLAYED, AND FIXING THE PENALTY FOR THE VIOLATION HEREOF.

The City Council of the City of Torrance does hereby ordain as follows:

Section 1. It shall be unlawful for any person, firm or corporation in the City of Torrance to permit, suffer or allow any person under the age of eighteen years, or for any person under the age of eighteen years, to play the games of skill hereinafter defined.

Section 2. It shall be unlawful for any such person, firm or corporation to permit, suffer or allow any person over the age of eighteen years, or for any person over the age of eighteen years, to play any such games of skill until a license therefor has first been obtained from the City of Torrance by such person, firm or corporation having the custody or possession of the same as hereinafter provided.

Section 3. The games of skill referred to in Sections 1 and 2 hereof shall be defined, to-wit: any games of skill, played on marbles or other objects of a similar nature, upon, under, in or about any table, machine or device, whether such marbles or other similar objects are propelled or otherwise moved upon, under, in or about such table, machine or device, or any part thereof, by a mechanical contrivance or otherwise, and/or whether such marbles or other similar objects are so propelled or moved as aforesaid under glass or other cover, or not.

Section 4. The license therefor shall be \$15.00 per annum for each table, machine or device upon which such games are played, payable annually in advance. The license for the remainder of the fiscal year 1934-35 shall be \$10.00 for each such table, machine or device, payable immediately after the date this ordinance becomes effective.

Section 5. Any such person, firm or corporation violating any provision of this ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine not exceeding \$300.00 or by imprisonment in the City or County Jail for a period not exceeding ninety (90) days, or by both such fine and imprisonment. Each game played in violation of this ordinance shall be deemed to be a separate offense hereunder. The licenses provided for herein shall be due and payable as aforesaid immediately upon any such table, machine or device being displayed for use by the public, whether any game or games are played thereon.

Section 6. If any section, subsection, sentence, clause, phrase or word of this ordinance is for any reason held to be invalid or unconstitutional, such that the whole shall not affect the validity of the remaining portions of this ordinance, The City Council hereby declares that it would have passed this ordinance, and each section, subsection, sentence, clause, phrase, or word thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, phrases, or words be declared invalid or unconstitutional.

Section 7. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 8. The City Clerk shall certify to the passage and adoption of this Ordinance by said City Council, and shall cause the same to be published by one insertion in the Torrance Herald, a weekly newspaper of general circulation, published and circulated in the City of Torrance, and
