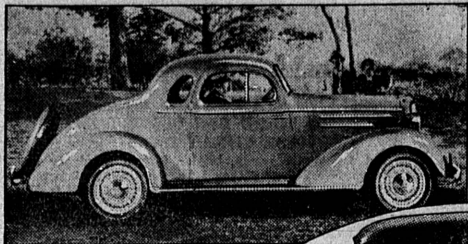


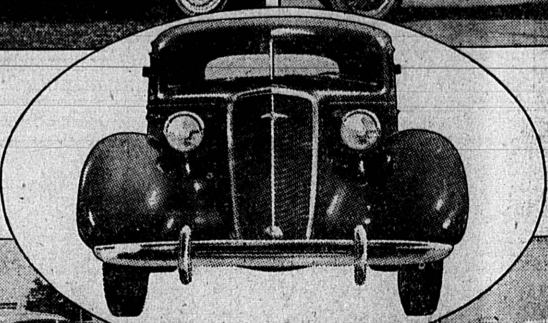
Chevrolet Announces Two New Lines for 1935



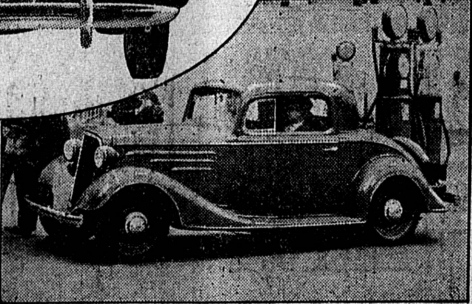
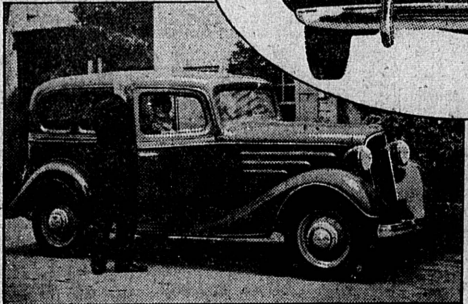
The Coupe model typifies the beauty and style of Chevrolet's new Master De Luxe series for 1935. Improved performance and exceptional economy also characterize these cars.

CITY NAMED BETHLEHEM
193 YEARS AGO YULETIDE
BETHLEHEM, Pa. (U.P.)—One hundred and ninety-three years ago this Christmas this city was named Bethlehem.
The scene of the event was a stable adjoining the first house in the town. The site is now marked with a bronze tablet.
The services were conducted by a new arrival in the colony, Count Nicholas Ludwig von Zinzendorf. The count led the way to the stable, carrying a lighted candle and singing a German hymn.
Before the close of the service the congregation sang, "Christ, Whose Glory Fills the Skies," and the sacristans appeared carrying lighted wax candles, distributing them throughout the assemblage.
