

Accounting Work For District Is Moved Elsewhere

Office in Long Beach Will Handle Records in Welfare Work

All accounting work for the Torrance welfare district will be done henceforth at an office to be established immediately at 1095 American avenue, in Long Beach, as an economy measure approved by the board of supervisors this week.

Seven such offices are being established throughout the county, each to handle the accounting work of from three to five surrounding welfare districts. Action of the supervisors this week was in reality an expansion of the system to take in all welfare districts, it having been tried out for several weeks in several downtown Los Angeles districts.

Henceforth all bookkeeping work for each district office has been done at the district headquarters. Under the new plan it has been found that with a staff only slightly larger than that normally required for one office it will be possible to keep the records for from two to four other district offices. This will mean that visitors and investigators will have nothing to do with records in district offices hereafter, it was explained to the supervisors.

Approval was given the plan by the county efficiency bureau, it was explained to the supervisors by Tex Thomson, charities superintendent, and the same system is being installed by the federal government in its relief set-up.

On motion of Supervisor John R. Quinn, the supervisors authorized Thomson to expand it to take in the local and all other welfare district office accounting work.

The blow-in came at 1:30 o'clock, and for a number of hours the surrounding territory was sprayed with a muddy torrent. The well is located about two blocks east of Vermont near 128th street.

Precipitation Company Employee Dies From Hurts

Joseph H. Soulek, an employee of the Western Precipitation Company, Los Angeles, died at the Jared Sidney Torrance Memorial hospital Tuesday morning, from injuries received Saturday evening, when his car overturned on Vermont avenue. Soulek had been doing some work for the Precipitation company at the plant, and was on his way to Los Angeles at the time of the accident.

According to the report made by the investigating officers from sub-station No. 3, Soulek's car had turned over and rolled about 100 feet. From the marks on the pavement it appeared that he had turned out to pass another car when his machine went out of control.

Soulek's skull was fractured, and he sustained numerous body contusions.

Soulek had been staying at the Southern Inn in Torrance while his wife was visiting her people at 742 Belvedere street, Pasadena, for a short time while he was engaged in the work here. An inquest was held at Stone & Myers mortuary yesterday morning, to establish the circumstances regarding the accident, following which Soulek's body will be shipped to Minnesota for burial.

Midwinter Poultry Show Starts Today

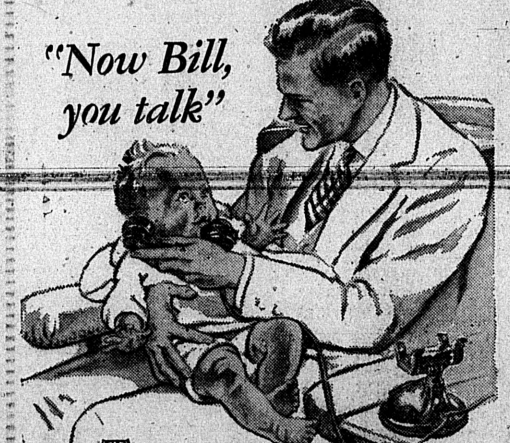
