### Beauty and Brains Co. Ordinance Permits Smoking In Theaters



Patrons in Unincorporated Area Have Restrictions Removed

Today, April 18, is the effective date of the new county ordinance which will permit smoking in the balconies of theatres in Lomita and other unincorporated territory, providing the building is of "fire resistive construction."

The ordinance was adopted on March 18 by the board of supervisors. That part of the ordinance governing smoking in theatres in unincorporated territory is set forth as follows:

"It shall be unlawful for any person, firm or corporation to smoke or permit the smoking of any cigar, cigarette, pipe or tobacco in any form whatever on any stage or any theatre or moving picture during any performance, except to the extent that smoking is a part of the play or production;

"It shall be unlawful for any person, firm or corporation to smoke or permit the smoking of any cigar, cigarette, pipe or tobacco in any form whatever elsewhere in any theatre or moving picture theatre during any performance EXCEPT in the retiring rooms, smoking rooms, mezzanine floor, balconies or stadium type balcony in theatres or moving picture theatres of fire resistive construction."
