ORDINANCE NO. 265
AN ORDINANCE OF THE CITY OF TORRANCE, CALIFORNIA, PROVIDING FOR THE ISSUANCE OF BONDS OF ACT OF 1927 MUNICIPAL IMPROVEMENT DISTRICT NO. 1 OF THE CITY OF TORRANCE IN THE AMOUNT OF TWO HUNDRED THOUSAND DOLLARS (\$200,000.00) (PART OF AN ISSUE OF \$400,000.00), AUTHORIZED AT A SPECIAL ELECTION HELD SEPTEMBER 25, 1930, FOR THE PURPOSE OF ACQUIRING AND CONSTRUCTING THE WATER WORKS SYSTEM FOR SAID DISTRICT AND THE SALE OF \$125,000.00 OF SAID BONDS TO THE UNITED STATES OF AMERICA, AT PRIVATE SALE, AND REPEALING ORDINANCE NO. 263 OF SAID CITY.

WHEREAS, in pursuance of an act of the Legislature of the State of California, entitled "An Act to provide for the formation of districts within municipalities for the acquisition or construction of public improvements, works and public utilities; for the issuance, sale and payment of bonds of such districts to meet the cost of such improvements and for the acquisition or construction of such improvements," approved May 24, 1927, and Resolution No. 471 of the City Council of the City of Torrance adopted September 2, 1930, a special election was duly held in that certain territory contained within the boundaries of Act of 1927 Municipal Improvement District No. 1 of the City of Torrance, particularly described in said Resolution No. 471, upon the following proposition: "That certain proposed Municipal Improvement District known as Act of 1927 Municipal Improvement District No. 1 of the City of Torrance incur a bonded debt of Four Hundred Thousand Dollars (\$400,000.00) for the purpose of creating an indebtedness to be represented by bonds of such district to pay the cost and expense of acquiring and constructing a water producing and distributing system for said district, including wells, pumps, tanks, reservoirs, distribution mains and land rights of way, and easements therefor and all other necessary equipment and appurtenances for a complete water producing, purifying, and distributing system for the sale of water for domestic, agricultural, industrial and other uses?"

WHEREAS, according to the returns of such election as canvassed by the City Council of such City on September 29, 1930, the result of which canvass was then and there ascertained, entered, declared and recorded according to law, more than two-thirds of all the voters voting at said election did vote in favor of incurring the bonded indebtedness as described in said proposition so submitted at said special election, thereby authorizing and empowering said Council to issue the bonds of said district for the amount of Four Hundred Thousand Dollars (\$400,000.00) for the purposes aforesaid, payable out of the funds of said district, to be provided for as in said Act prescribed; and
WHEREAS, two hundred thousand dollars (\$200,000.00) principal amount of said bonds were issued by Ordinance No. 254 and have been regularly sold to a purchaser of said bonds for the sum of one hundred and thirteen thousand dollars (\$133,000.00) of said bonds were ordered issued by Ordinance No. 263 of said City, and it is desirable that said Ordinance No. 263 be repealed and that provision be made for the issuance of said two hundred thousand dollars (\$200,000.00) of bonds; NOW, THEREFORE, the City Council of the City of Torrance does ordain as follows:
Section 1. That bonds of said Act of 1927 Municipal Improvement District No. 1 of the City of Torrance in the principal amount of two hundred thousand dollars (\$200,000.00) be issued in accordance with an Act of the Legislature of the State of California, entitled "An Act to provide for the formation of districts within municipalities for the acquisition or construction of public improvements, works and public utilities; for the issuance, sale and payment of bonds of such districts to meet the cost of such improvements and for the acquisition or construction

of such improvements," approved May 24, 1927, for the purpose of acquiring and constructing the improvements mentioned in the proposition set forth in the recitals hereof; that said bonds shall be two hundred in number and each shall be designated "Act of 1927 Municipal Improvement District No. 1 of the City of Torrance Bond"; they shall be of the denomination of \$1000.00 each, and the principal and interest thereof shall be payable in lawful money of the United States at the office of the Treasurer of said city, or at the option of the holder, at the Central Hanover Bank and Trust Company, in the Borough of Manhattan, City and State of New York; they shall be dated July 1st, 1934, and shall bear interest at the rate of four percent (4%) per annum, payable semi-annually on the 1st day of January and the 1st day of July of every year; said bonds shall be numbered from 201 to 400, inclusive, and shall be payable in numerical order, eight bonds each year commencing on the 1st day of July, 1934, and ending on the 1st day of July, 1965, both inclusive; said bonds shall be registerable as to both principal and interest at the option of the holder.

Section 2. Said bonds shall be in substantially the following form:

Under and by virtue of an act of the Legislature of the State of California, entitled "An Act to provide for the formation of districts within municipalities for the acquisition or construction of public improvements, works and public utilities; for the issuance, sale and payment of bonds of such districts to meet the cost of such improvements and for the acquisition or construction of such improvements," approved May 24, 1927, Act of 1927 Municipal Improvement District No. 1 of the City of Torrance, in the City of Torrance, State of California, its governing body, the City Council of said City of Torrance, promises, out of the fund hereinafter described, to pay to the bearer on the 1st day of July, 1934, (date of maturity), the sum of \$1000.00 with interest thereon at the rate of four percent (4%) per annum, payable semi-annually on the 1st day of January and the 1st day of July of each year from the date hereof until this bond is paid, upon presentation and surrender of the interest coupons hereto attached as same fall due, principal and interest payable in lawful money of the United States, at the office of the Treasurer of said City of Torrance in said city, or at the option of the holder, at the Central Hanover Bank and Trust Company, in the Borough of Manhattan, City and State of New York.
