

L. A. Attorney Writes City On Carrigan Case

Torrance Official Invited For Conference On Wednesday

In response to a letter from Walter I. Lyon, Los Angeles attorney, addressed to officials of the city of Torrance, City Attorney Charles W. Rippe conferred with the attorney on Wednesday in regard to the unfortunate occurrence of May 26, 1935, when John P. Carrigan was found dead in the city jail.

Carrigan had been placed in jail on Sunday, May 19, at the request of his wife on a charge of being drunk. He was last seen alive about 2 o'clock the following morning, and his lifeless body was found on the floor of the corridor leading to a cell shortly after 5 o'clock, or about six hours later. Examination of the body showed a gash in his scalp.

An autopsy performed by Dr. Shaffer of the coroner's office gave probable acute alcoholism as the cause of death. No inquest was held and the body was shipped to Ohio for burial.

On arrival in the east a second autopsy was performed by Dr. H. Hauser, of Youngstown, Ohio. An inquest was called for and held in Los Angeles on June 10, when testimony of local witnesses was taken and the report of the Ohio coroner was introduced.

The jury, composed of R. L. Haines, foreman, Wm. B. Kline, K. D. Rusby, Paul H. Rew, H. B. Laughlin, R. E. Bolstead, Raymond Chino and G. W. Middleton, returned the following verdict, an official copy of which was

received by the Herald this week: "We, the jurors summoned to appear before the coroner of Los Angeles county at Room 102 Hall of Justice, Los Angeles, California, on the 10th day of June A. D. 1935, to inquire into the cause of the death of John Peter Carrigan having been duly sworn according to law, and having made such inquisition and hearing the testimony adduced, upon our oaths, each and all do say that we find that the deceased was named John Peter Carrigan, a male, married, a native of Ohio, aged about 48 years, and that he came to his death on the 26th day of May, 1935, at 1815 Cravens avenue, Torrance, Los Angeles county, California, and that this death was caused by probable acute alcoholism. There is a history of the deceased being placed in the Torrance city jail on a charge of being drunk by the request of the wife of said deceased May 19th, 1935, and we the jury are unable to determine whether the deceased died as a result of acute alcoholism or by injuries sustained in some manner unknown."

2,000,000th V-8 Comes West

The two millionth V-8 Ford—the one millionth Ford built in less than 12 months and approximately the 23,000,000th Ford ever built—is headed for America's Exposition, San Diego, where it will be placed on exhibition July 6th.

Henry Ford, founder, and Edsel Ford, president of the Ford Motor Company, watched the final assembly of the historic Ford. The car rolled off the assembly line of the Rouge plant June 13th, just six days less than a year since the one millionth car was manufactured June 19th, 1934, recalling Mr. Ford's prediction late last year that the Ford Motor Company would "build better than a million in 1935."

The two millionth V-8 is the fourth historic Ford car which has blazed a transcontinental trail to the Pacific Coast, each over one of the four principal trunk highways between the Atlantic and Pacific.

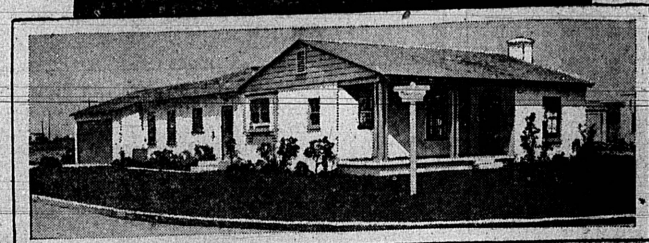
