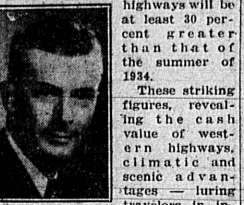

Motor Traffic On the Coast Will Increase 30 Percent This Summer

At least 100,000 automobile parties, averaging three persons to a car, will have traversed the splendid highways of Washington, Oregon and California by the close of the present four-months' vacation season. Most of these tourists come from other states. Their expenditure, for the season in the coast states, is approximately \$185,000,000.

Motor traffic on Pacific coast highways will be at least 30 percent greater than that of the summer of 1934. These striking figures, revealing the cash value of western highways, climatic and scenic advantages—luring travelers in increasing thousands from all parts of the world—were recently secured by H. J. Macdonald, manager of the real estate department of the General Petroleum Corporation.

Returning to the head offices of the company in Los Angeles, from a 5,500-mile motor tour of the Pacific Northwest and California, this General Petroleum executive had become so impressed with the large number of travelers he saw from distant states that he started a little private investigation to ascertain what prosperity these motorists bring to the coast states.
