Full Details of Bonded Debt Is Asked By State

Cities, Counties and Districts Must Report to Finance Department

Cities, counties and all other bond districts must report full details of their bonded indebtedness to the state department of finance by November 14, under terms of an act passed by the 1935 legislature, Deputy Attorney General James S. Howie pointed out this week. The penalty is removal of the auditor or other similarly responsible officials.

Purpose of the act is said to be the obtaining of information which may form the basis for any future tax program contemplated at the next session of the legislature.

Besides cities and counties, other units affected by this act include: School districts, irrigation, water, drainage, street improvement, reclamation and all other districts or governmental subdivisions having the power to borrow money or create indebtedness against themselves or any property within their jurisdiction.

No special forms have been prepared for these reports, according to word Howie received from the office of State Finance Director A. E. Stockburger, hence the units will be required to use their own forms.

The special information required under this act, known as Chapter 52 of the Statutes of 1935, includes:

Name of the issue.
Denomination or denominations.
Number of bonds of each denomination.
Total indebtedness represented by such bonds.
Interest rate and dates of payment of such interest.
Maturity date or dates.
Whether or not such bonds are callable, and if so, the terms and date or dates upon which they may be called.
Method of raising revenue to pay the interest and principal of such bonds.

Mayor Shaw's Plan to Consolidate City & County Governments Scanned Lest Torrance Be made the "Goat"

Consolidation of the governments of the city and county of Los Angeles is favored in a report under consideration today by the special governmental committee of 21 appointed by Mayor Frank L. Shaw.

The report was prepared by John A. Rush, a temporary vice chairman of the committee, who, however, expressed the desire that it be regarded wholly as his own attitude and not, for the present, an expression of the views of any group in the mayor's committee.

Rush declared that a 40 percent reduction of taxes was brought about in 1856 when the state legislature created the city and county of San Francisco.

He cited similar consolidations of governmental functions carried out by Baltimore, Philadelphia, New Orleans, St. Louis and Denver.

It was recommended that the committee consider seven possible ways for simplifying government and from them choose one plan for endorsement.

According to Rush, the next logical step would be the appointment of a legal committee to ascertain what legislation would be necessary for carrying out the proposal.

A sub-committee to report on the benefits to the city of Los Angeles which might derive from the plan selected also was suggested.

Officials and other citizens of Torrance are considerably concerned over the persistent attitude of Mayor Shaw and other Los Angeles officials to effect a consolidation of city and county governments. Local civic leaders are plainly worried over the possibility of being drawn into the consolidation with a resultant increase of taxes to Torrance property owners and the loss of the city's control of purely local matters.
