



**Judge Lindsay Not Intimidated By Threat Made Over Telephone**

Threat of political reprisal for supporting Harlan G. Palmer for district attorney made against Judge Ben B. Lindsey bounced back against those who made the threat this week, according to Albert Mellinkoff, manager for the volunteer campaign committee for Palmer's election.

Though angered by the telephone threat, Judge Lindsey merely answered: "I will meet you at Thermopylae."
