Early Settler Of Lomita Is Taken by Death

Well Known Lumberman Passes Away At Home Yesterday

James Wilkinson, 73, well known resident of Lomita where he had resided for a quarter of a century, passed away at his home, 1938 259th Place, yesterday morning, Oct. 14. His passing brings to a close the useful career of one who had been a witness to the growth of California and especially the harbor district over a period of 43 years.

Mr. Wilkinson was born in Yorkshire, England, Oct. 28, 1862. He came to the United States at the age of 18, and three years later joined the westward movement of early settlers which brought him to California. For 40 years he was employed by the Banning Company, as lumber foreman, and retired about two years ago after an injury.

Some years ago, before the days of the paid departments, Mr. Wilkinson was a member of the volunteer fire department of San Pedro. He was a member of the Red Men lodge and also held a life membership in the Order of Eagles. He had been an accomplished singer and for a number of years sang in the choir of the Baptist church at San Pedro and also in the choir of the Community Presbyterian church at Lomita.

He leaves his widow, Mrs. Fanny Wilkinson; two daughters, Mrs. Lily Willacy, of Lomita, and Mrs. Mary McKay, of Los Angeles, and a son, George, of Los Angeles. Judge Windle, well known official of Avalon, Catalina Island, is also a relative.

Funeral services will be held Saturday afternoon, at 2 o'clock, from the Community Presbyterian church in Lomita, Rev. Orr officiating. Interment will be made at Roosevelt Memorial park. The A. M. Gamby mortuary is in charge of arrangements.

Funeral services were held Saturday morning at 11 o'clock from the Little Church of the Flowers, for Warren Dennis, of Glendale, who passed away early Thursday morning. The last rites were conducted by Rev. George G. Elder, pastor of the First Christian church, of Torrance, and interment was made at Forest Lawn. He is survived by his widow, Mrs. Elsie Dennis, one daughter, Mrs. Mildred Edwards, 2208 Andreao avenue, and one son, Clarence Dennis.
