1. Grading for widening of present pavement and construction of gutter; estimated excavation 690 cubic yards.
2. Provide and place 185 cubic yards of sand for cushion.
3. Furnish and place 7,280 square feet of 6-inch asphaltic concrete pavement; estimated requirement 272 tons.
4. Place 375 lineal feet 2x8 R. O. F. headers.
5. Furnish and place 62 lineal feet 8-inch corrugated pipe; 18 gage.

BID B—For resurfacing and widening pavement along the south roadway of Torrance Boulevard from Western Avenue to 218th Street, consisting of the following work and improvement—

1. Finish grading 7000 square feet, estimated at 150 cubic yards.
2. Furnish and place 1500 lineal feet 2x8 R. O. F. headers.
3. Construct 90 lineal feet of 15-inch concrete curb, 20% lineal feet of reinforced concrete retaining wall requiring 3 1/2 cubic yards of concrete.
4. Pave with 6-inch asphaltic concrete 7000 square feet, using 281 tons of concrete and resurfacing with asphaltic concrete 1 1/4-inch thick 61,446 square feet of roadway, requiring 462 tons of asphaltic concrete.

Work embraced herein shall be done in accordance with the appropriate provisions of construction details, Sections 10 to 72, inclusive, of the specifications entitled "State of California Department of Public Works Division of Highways Standard Specifications January, 1935," insofar as the same may apply.

California Voters Set New Record With Ballots

Credit it to the personal popularity of President Roosevelt, the weather, the times or whatever you wish, but the fact remains that California voters took more interest in the 1936 presidential election than ever before in the history of the state.

Official Nov. 3 election figures compiled by Secretary of State Frank C. Jordan show that more voters, both numerically and proportionately, marched to the polls to cast their ballots than at any other time.

The total vote cast amounted to 2,712,342, or 88 percent of the official registration of 3,063,831. Of this total, the Roosevelt-Garner ticket garnered 1,766,523, or 930,405 more votes than the 836,481 credited to the Landon-Knox ticket.

Changing Trend
 The highly complimentary vote given the Bourbon leaders represents a continuation of the changing trend in California politics started some years ago. Back in the 1928 Presidential election, Herbert Hoover was tops with the California electorate which gave him 1,162,323 votes, almost double the 614,860 credited to Al Smith in the official records. The total vote that year was 1,948,027.

In 1932 the Democrats began to show their strength and handed the state over to Roosevelt with 1,324,157 votes while Hoover dropped down to 847,902. The total vote then amounted to 2,330,182. This year, Landon failed to equal even the Hoover showing of '32, and Roosevelt added another 449,670 to his substantial total of the previous election.

State Test Due On Hunt Well

Having sunk a 10-inch casing down to the 3,000-foot level, the Hunt Oil company is awaiting a state inspection today at its deep-test well off the intersection of Hawthorne and Sepulveda boulevards. Deep-sand activity is continuing in the southwest slope of the old Torrance oil field with Dunlap reported going in a few hundred yards west of the Hunt well off Sepulveda and C.O.M.O., preparing a deep thrust on the opposite corner to the Hunt exploration.

As soon as the state test is completed, the Hunt workers will drill out the plug and in a few days expect to put down an eight and five-eighths-inch casing. Then they will start taking cores.

Dearborn Oil company's Flint No. 1, off Sepulveda, is reported continuing a yield at the rate of 400 barrels a day of 28 degree gravity oil with a cut of 20 percent drilling mud and water. This deep-test job launched the leasing activity in this area two weeks ago.

Offset Well Planned
 It is a deepening job of the zone which was tapped by C. C. M. O. in its Del Amo No. 23. The well was bottomed at 4,566 feet with four and three-quarter-inch combination shut-off at 4,300 feet taking in 256 feet of zone. This well was originally drilled by Standard Oil to 3,751 feet and abandoned some time ago.

Killingsworth Bros. is reported as preparing to drill an offset well on the north, while Fullerton Oil will start work on its lease to the east. Signal Oil of California is a joint project with Dearborn Oil are planning to deepen old Standard Oil Flint No. 2.
