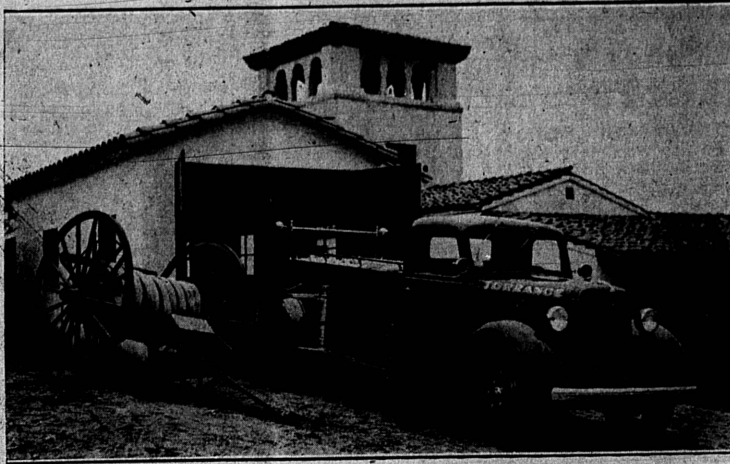

24-Year-Old Veteran Retired By Reincarnated Garbage Truck

With the delivery Saturday of engine No. 3, formerly the old city garbage truck—but no one would recognize it now, the city's first fire-protection apparatus was once more honorably retired from service.

The glistening triple combination truck costing \$2,250 was installed with appropriate ceremonies at the recently-built fire station in Hollywood Riviera adjoining the administration building, and the old hose-wheel cart was returned to its resting place in the central station garage. The cart was first put in service here in 1912.

Constructed by the R. G. Davis Company and delivered by the head of that Los Angeles firm in person, the 200-gallon booster pumper, hose and chemical truck was the center of attraction here and at Hollywood Riviera last week-end. It is now being manned there by a volunteer fire-fighting force headed by Roy C. Stewart, manager of the Hollywood Riviera clubhouse.

Carried in the gleaming red body are 1,000 feet of hose, ladders and other new type equipment that will provide the beach community with excellent fire protection.

tom of Mondays when Christmas comes the latter part of a week. People spend the week-end shopping, wrapping and preparing gifts for mailing, and then storm postal centers on the first day of the week to get their presents off.

Seven extra workers are now employed here to assist the regular force in getting the mail out. The windows will close every evening at 6 o'clock and all mail to arrive on or before Christmas Day will be delivered. Postmaster Conner said. Deliveries will be made Dec. 25 but the postoffice will be closed. There will also be two deliveries made Saturday, Dec. 26.

The postmaster has provided a wrapping table and a generous supply of twine for patrons whose packages are judged inadequately wrapped. However, very few parcels are found insufficiently prepared for shipment and Conner expressed commendation for the way most packages are submitted for shipment.

Resting While Working
Following exhibition of the presents — hand-painted plates, vases, buttons, Christmas cards — all made of cast-offs which have been transformed into attractive articles by children from three to 11 years of age, a Christmas party was given by Mrs. Sapp to the youngsters who made them. This was held Friday afternoon.

"The children come here after school hours to do what they like to do. They are really resting mentally as they work on something they have planned and designed themselves. We furnish most of the materials although many of our boys and girls brought their own supplies," Mrs. Sapp said.

"The boys appear to be the happiest—they laugh, sing and whistle as they work while the girls are more serious, want to be busy without conversation. We hope to expand this work to include the Keystone district soon because it provides an after-school period of instructive recreation."

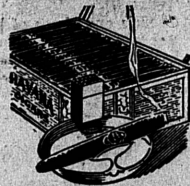
