SECTION 2. All ordinances and/or parts of ordinances in conflictorewith are hereby repealed.

SECTION 3. Any person, firm, or corporation violating any of the provisions hereof shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine not exceeding on hundred dollars, or by imprisonment for not more than fifty days, of by both such time and imprisonment.

SECTION 4. The City Clerk shall certify to the passage an adoption of this Ordinance by the said City Council, and shall cause the same to be published by one insertion in the Torrance Herald, weekly newspaper of general circulation, published and circulated is the City of Torrance, and thereupon and thereafter the same shall in full force and effect.
