Ford Exhibit Steel Rises At San Diego Exposition



Out on the tip of a promontory skirted by three deep gulches, hundreds of wo kme are engaged in welding four hundred and fifty tons of great steel trusses and griders for the framework of the Ford Motor Company's exhibit palace at the California Pacific International Exposition in San Diego, which opens May 29.

Present indications are that the framework will be in place before the scheduled date, April 15. When the thousands of yards of reinforced concrete have been poured, the great circular edifice will take form overlooking a series of terraces on which will be shown replicas of the famous roads of the Pacific. Already the terraces are formed and bits of these old trails are taking series.
