Torrance Voters Are 2nd Largest District Group

The 12 precincts of Torrance roll up more votes than any other part of the 68th assembly district except San Pedro, and the Torrance registration shows that the Roosevelt Democrats far outnumber all other party registrations. For this reason the Roosevelt-Rawls campaign committee, headed in Torrance by A. H. Bartlett, Judge Robert F. Lessing, Dr. Geo. P. Shidder and others are bending their energies to getting out the largest Democratic vote ever recorded in a primary election in Torrance.

Supplementing the efforts of the committee are the Torrance women who have joined in the organization of the Democratic Women's Study Club of the 68th assembly district, the first meeting of which was held July 30.
Strong support came to the Rawls committee during the past week, when S. P. Stambuk, long a leader of the Slav colony in the harbor district, declared for Rawls for assembly and sent an interview to "Demovina," the Slav language newspaper, in which all members of the Slav colony are urged to support Rawls at the August primaries.
Another powerful endorsement came from the physicians and surgeons who have worked so long and so hard for what they term "organized medicine." The doctors are joining in Rawls' support because of the votes Rawls gave "organized medicine" during his term as assemblyman.
Torrance laboring men recall the endorsement of Rawls by the State Labor Council after his record-making votes on labor bills during his incumbency. They argue that performance is better than promise and are supporting Rawls for that reason.

Plunge Engineer Is Wounded

Jeremiah Dempsey, 215 Garnet, Redondo Beach, was brought to the Jared Sidney Torrance Memorial hospital Monday night, suffering from a bullet wound, said to have been self-inflicted. Dempsey has been for years employed as engineer at the Redondo plunge. His alleged attempt at self-destruction is said to have followed an altercation with his wife.
The bullet struck a rib, shattering the bone and failed to enter the chest, so that the wound while painful is not believed to be serious unless complications develop. Dempsey was later removed to the California Lutheran hospital in Los Angeles for further treatment.

Mystery Ship Is Anchored Off Hermosa Shore

Magdalena Bay, luxury fishing liner under the management of Ralph Bandini, author and sportsman, was opened to the public last Saturday. The ship is anchored two miles off the pier at Hermosa Beach.
Every comfort and convenience is offered to fishermen. Each has a reserved seat with full tackle and bait facilities at hand, and whenever he hooks a fish a uniformed attendant removes it and packs it away in the \$10,000 refrigeration plant where it remains until the fisherman is ready to go ashore.
Other features include a lounge, cafe, solarium, sand pile playground for children, cocktail lounge and stateroom accommodations for those who want to spend a night or a week on board.
The Magdalena Bay has had a colorful history. During the World War she was a mystery ship, disguised as a slow freighter, to lure submarines within striking distance when her falsework dropped away disclosing a row of guns ready for action. After the war she plied between the Pacific Coast and Mexico under the name "Chiapas" and still later was known as the pleasure ship La Playa, La Playa Ensenada, and Star of Hollywood. Now she lies at anchor off the west coast shore to be used as a fishing boat. How are the mighty fallen.

ORDINANCE NO. 285
AN ORDINANCE OF THE CITY OF TORRANCE AMENDING ORDINANCE NO. 49-A BY ADDING A NEW SECTION THERETO GOVERNING FEES FOR SIGNS AND MARQUISES.
The City Council of the City of Torrance does hereby ordain as follows:
Section 1. That Ordinance 49-A of the City of Torrance shall be amended by adding thereto a new section to be known as Section 6-A, which shall read as follows, to-wit:
"Section 6-A. FEES FOR SIGNS AND MARQUISES.
(a) The following fees shall be charged and/or paid for each sign and/or marquee having incandescent lighting and/or gas tube lighting, to-wit:
Each sign \$1.50
Each marquee (including signs thereon) 1.50
Each transformer for a sign or marquee25
1 to 10 receptacles therefor25
11 to 25 receptacles therefor50
26 to 50 receptacles therefor 1.00
51 to 100 receptacles therefor 2.00
101 to 200 receptacles therefor 3.00
201 to 500 receptacles therefor 5.00
Over 500 receptacles therefor 8.00
Shop inspection, each sign 1.50
(b) The word receptacle as used in this section shall include every lighting socket, lampholding device and/or other receptacle for a lamp.
(c) The fees specified in

this section for transformers, receptacles and/or shop inspection shall be added to the fee of one dollar and fifty cents (\$1.50) required for each sign and/or marquee.
(d) SIGN FLASHER ONLY. In any case where a sign flasher is installed on and/or for an existing sign and/or an existing marquee, a fee of one dollar and fifty cents (\$1.50) shall be charged and/or paid for not to exceed one (1) such sign flasher, and an additional fee of twenty-five (25) cents shall be charged and/or paid for each such additional sign flasher.
(e) SHOW WINDOW AND SHOW CASE LIGHTING. A fee of one dollar (\$1.00) shall be charged and/or paid for each twenty (20) sockets and/or receptacles, or fraction thereof, for show window and/or show case lighting.
(f) TROUGH LIGHTING. A fee of one dollar (\$1.00) shall be charged and/or paid for each fifty (50) sockets and/or receptacles, or fraction thereof, for trough lighting or battery lighting.
(g) OUTLINE LIGHTING. A fee of one dollar (\$1.00) shall be charged and/or paid for each fifty (50) sockets and/or receptacles, or fraction thereof, for outline lighting.
(h) GAS TUBE LIGHTING. A fee of one dollar (\$1.00) shall be charged and/or paid for each two (2) transformers, or fraction thereof, provided, however, that this provision shall not apply to gas tube lighting on signs and/or marquee.
(i) THEATER BORDER LIGHTING. A fee of one dollar (\$1.00) shall be charged and/or paid for each fifty (50) sockets and/or receptacles, or fraction thereof, for theater border lighting.
(j) THEATER FOOT LIGHTS. A fee of one dollar (\$1.00) shall be charged and/or paid for each fifty (50) sockets and/or receptacles, or fraction thereof, for theater foot lights and/or stage foot lights."
Section 2. The provisions of Ordinance 49 and 49-A are hereby referred to and made a part hereof.
Section 3. The City Clerk shall certify to the passage and adoption of this ordinance by said City Council, and shall cause the same to be published by one insertion in the Torrance Herald, a weekly newspaper of general circulation, published and circulated in the City of Torrance, and thereupon and thereafter the same shall be in full force and effect.
