New Daniels Cafe to Open On Saturday

Special Introductory Prices To Be Featured On Opening Day
 With the new equipment installed and the room redecorated, the new Daniels Cafe at 1525 Caballo avenue, owned in partnership by the two Daniels brothers, Lewis and Howard, started serving meals early this week.
 The actual formal opening of the cafe has been set for Saturday this week when a special menu will be featured consisting of a roast turkey or steak dinner for 50 cents and numerous other specials for the new establishment's official introduction to Torrance people.
 The delayed opening was explained by Daniels to be for the purpose of giving the staff a chance to become used to the new place and to establish an efficient routine. It was therefore decided to serve meals for a few days prior to the public opening to assure a successful initiation of the new eating house.
 The Torrance establishment is the fourth to be added to the group owned and operated by the Daniels brothers. Their other cafes are located in Hollywood, Gardena and Lomita.
 Howard Daniels will have charge of the Torrance restaurant which gives promise of becoming one of the largest of their establishments.
 Occupying the quarters which formerly housed Earl's Cafe and which have been attractively renovated, the new Daniels establishment is advantageously located and will be open from 6 o'clock a. m. to 12 o'clock p. m. to provide convenient service for the men employed by the local manufacturing plants.
