S. C. LIVING **COSTS GAIN**

Advance Begun in April

Living costs in Southern Califormis, taken in the aggregate,
continue a rather steady rise
that began in April, 1934, but
under present circumstances
should rise less rapidly in the
next six months. Such is the
observation and prediction of
the Southern California Business
Review in the October issue.

Foods in this area show a
slight downward trend in costs,
and are still 12 percent below
a dozen other metropolitan centers in the country, according to
the Review. The furniture market, increasing about seven percent since March, seems fairly
tt-bilized at present and should
remain at the present level for
some time.



Walteria Bus Effort Fails

Apparently there is nothing the city of Torrance can do to btain free school bus transporation for Walteria pupils to the larbonne high school. This beame evident last night as City ttorney C. T. Rippy read a engthy opinion and statement rom Attorney General U. S. Vebb.

Altho the distance from the homes of 34 pupils whose parents petitioned for the free transportation to the high school in Lomita is approximately three miles, the Los Angeles board of education has declined to provide this gratis service and is not bound by any law to do so. The board has said the cost would be prohibitive. It agrees that the distance is excessive but has announced that it would only furnish free transportation to those unable to pay.

From Rippy's and Webb's statements, it was evident that the only recourse is to have the statutes regarding school transportation. Webb's opinion, while not based on the Walteria case, was about a similar situation in Sisklyou county.

"About the only thing we can do now," Mayor Stanger said, "is to give the Walteria people those opinions. That is as far as we can go in the matter."

Women WPA **Workers Laid** Off In County

More than 2000 women with dependent children have been laid off of their Works Progress Administration jobs in Los Angeles county, and an additional 800 were to be laid off this week, according to information released from the Los Angeles offices of the WPA.

This move is in accordance

This move is in accordance with the workings of the Federal Social Security Act and only those who are eligible for aid are being transferred. In this instance women who have dependent children under the age of 16 are affected. A recent survey has revealed that the dependent children are receiving inadequate attention while their mothers have been working with

pendent children are receiving inadequate attention while their mothers have been working with the WPA. Fourteen Torrance women were dismissed from the sewing project here.

Children Gauge Pay
Until the time in the near future when they shall start receiving aid from the Social Security Act, the women will be transferred to the L. A. C. R. A. The relief they are to receive from the L. A. C. R. A. will depend on the number of their depend on the number of their depend on the number of their dependent children.

A woman with one child less than three years of age, \$28.33; with two children, three to five and six to eight, \$37.26; two children, 14 to 16 and nine to 13, \$41.86, and so on. In addition to this they are eligible to receive surplus commodities such as clothing and garden produce.

As a result the women will receive approximately the same amount of compensation as they had been receiving while working with the WPA but allowance is being made for the fact that they will be spared the expense of hiring carefakers for their children and paying carfare, innehes and other expenses, it was pointed out.
