Multi-Named Road Project Ready In June

July will see the completion of the so-called State street project through Long Beach and Signal Hill, completing the state route that will by-pass coast motor traffic around Los Angeles to the west and south of Torrance, according to state highway engineers.

The new route, into which Sepulveda boulevard will eventually be tied, is variously known under names of Roosevelt Highway, Lincoln boulevard, Sepulveda boulevard and State street. An official designation is expected to be given some time this summer after completion of the two remaining links now under way in Long Beach and Signal Hill.

Pavement 76 feet in width is being laid on the project to make it adequate to accommodate heavy traffic that is expected upon its completion and opening this summer. Sepulveda boulevard comes to a junction with the new coast highway at the western edge of Los Angeles Municipal Airport, and only one short link will remain to be improved in Sepulveda before that will be a through route from San Fernando road to Long Beach avoiding the congested area of Los Angeles.

Meglin Studio Branch Opening

A local branch of the famed Meglin Dance Studio will be opened at the American Legion hall Friday morning, April 2, at 9:30 o'clock to offer instruction in tap and acrobatic dancing for both children and adults. The classes will be conducted here one day a week with the instructors coming from the Meglin studio in Los Angeles.

Full information may be obtained in advance of the registration day by phoning Redondo 2077 any time. Carolyn Hamilton, district manager for the studio, announces that Bess Richardson will be in charge of the Torrance studio registration.

Mrs. Richardson has been in Torrance for the past several days making final arrangements for the local instruction. She emphasizes that the classes will not be limited to juvenile talent and that while only tap and acrobatic dancing will be offered here at the present time, the Meglin Studios teaches all forms of ballet, voice and drama work.

Student Sailor Leaving to Continue Career

The ambition of many a boy—and older, too—is being realized by Phillip Jensen, 18-year-old son of Mr. and Mrs. H. G. Jensen of 1605 Amapol Avenue, as he continues his studies in the California Merchant Marine and looks forward to the day when he'll be skipper of his own ship.

He is on his way to becoming a trained third mate in this branch of service that, in Phil's opinion, has "more places open at the top than any other work." Tomorrow he breaks a brief vacation following a South Seas cruise aboard the U. S. S. California State to return to Tiburon, on the Sausalito side of San Francisco bay. He will join his fellow-cadets on the converted government freighter at Santa Barbara to go back to his classroom studies.

Young Jensen, a splendid specimen of young manhood, strong, bronzed and clear-eyed, will return home April 17 for a two-weeks vacation and then resume his second bout with his books on engineering, navigation and other subjects. After six months he will embark on his second cruise which he expects will take the cadet corps around the Horn.

Wants Deck Position

A graduate of Torrance high school with the spring class last year, Jensen was an outstanding grid player and an Eagle Scout. He took the Merchant Marine examination, a test similar to that given appointees for the U. S. Naval Academy at Annapolis, last June 6. He said this week that another examination for a new class will be given about that time this year.

Passing the requirements with high grades, Phil was enrolled with 107 other cadets for the three-year course, divided into six months of studies on land and six months actual sea training. He sailed last Nov. 21 from San Francisco for Tahiti and then, with only one major storm and several minor blows to break the monotony of the voyage, he visited Auckland, New Zealand; Melbourne and Sidney, Australia; Suva, Fiji; Pago Pago, Samoa; Honolulu and Hilo, Hawaii and landed March 18 at San Diego.

"The Merchant Marine offers a splendid career," he told The Herald. "Upon graduation we cadets are commissioned either as third mates or third assistant engineering officers, according to our preference and capabilities. I want a deck job as mate because I believe I am better fitted for that position."

Americans Welcome

Tuition is \$250 the first year and \$225 the second and third. This includes uniforms, board, laundry, medical attention and all necessary supplies. Forty-six of Jensen's class are young men from the Los Angeles area.

Stanger Given Honorary Police Captain's Badge

In recognition of his long service on behalf of the department, former Mayor W. H. Stanger was presented with a solid gold honorary police captain's badge last Friday. The badge is inscribed with the names of all members of the department and that of City Judge Robert Lessing.

Stanger, who is now manager of the Torrance Municipal Water District No. 1, was police commissioner here during his terms as councilman and mayor. He is a member of the police pistol team and is a crack shot.

Their ship was donated by the U. S. Navy to the state in 1928 for training young men for the Merchant Marine.

The most interesting port touched by the young mariner was Pago Pago because "the Oriental infiltration so noticeable in other parts of the South Seas has been prohibited there. As result, the Polynesian natives are allowed to continue their culture and trade without the competition that Japanese and Chinese have brought to the other islands."

New Zealand presented a most cordial welcome to the California cadets. All Americans are welcomed there because the New Zealanders are modeling their business, government and institutions on American styles, Jensen says. Business opportunities there and in Australia are unlimited for Americans.

Drainage of Slough Still Problematical

Only slight hope is held out for the immediate drainage of the Dominguez and Nigger Slough south of Torrance, it was admitted this week by County Flood Control officials. Both the PWA and the WPA have rejected the job, according to C. H. Howell, flood control engineer.

The only remaining hope is that the National Water Resources Board might include it in one of its projects. Howell declared the flood control funds of the county cannot be expected to finance the draining of a natural swamp.

Initial Claims for S.S. Death Benefits Asked

Believed to be the first death claims under the Social Security Act to have been started thru the government grist-mill from this city, two SS-3 forms are en route to Washington, D. C., from the National Supply Company.

Altho the beneficiaries will only receive about \$15, nevertheless the claims represent actual cash benefits as result of Federal legislation that went into effect the first of the year. According to Scott R. Ludlow, paymaster at the National Supply, the claims were made on behalf of two workers who died recently.

Should Obtain Forms

The family of the late John Dzados, of the Shoestring strip adjoining Torrance, is due to receive about \$10 which is three and one-half percent of the deceased's total wages from Jan. 1 until his death March 12. The benefit is to be awarded by the Federal government. Heirs of Griffith J. Reece, of 1739 Arlington Avenue, who was killed Feb. 18, are to receive about \$5. Mr. Reece was not regularly employed since the first of the year and had been ill several weeks.

The National Supply Company did not have the necessary forms to apply for the benefits and had to send to Washington for them. Ludlow says that all employers should obtain a supply of these forms in event of their use in the future.

Local Man Crushed Between Trucks in Wilmington Field

Baxter Larkins, of 21813 Hilldale Avenue, was fatally mangled between two trucks in the East Wilmington oil field Sunday in one of the most tragic mishaps to occur in recent months in this district.

His truck became mired in soft earth and when he saw another truck backing toward his vehicle, he stepped between the two machines with a rope on the assumption that a tow was being offered.



The light should also be hung so that it would shine on a sign and arrow pointing the way to the community, the petitioners requested. City Clerk A. H. Bartlett reported that he believed both the light and the sign were urgently needed. At Councilman George V. Powell's suggestion, Mayor W. H. Tolson referred the matter to the street committee.
