

Fatality Held Accidental

A coroner's jury probing the tragic death of Sam Bucher, 66-year-old night watchman at the city park the night of March 23, decided that the fatality was accidental and completely exonerated Michael E. Scanlon, 417 Narbonne avenue, whose car struck and killed Mr. Bucher.

The inquest was held last Friday morning at Stone and Myers' chapel with Deputy Coroner Kane officiating. Scanlon, who was accompanied by his wife the night of the accident, testified that he was driving about 25 miles an hour and did not see Mr. Bucher until the victim ran directly in front of his car.

Funeral services for the well-known worker were held Monday afternoon with the Torrance Masonic lodge in charge of the rites. Interment followed at Inglewood cemetery. Mr. Bucher is survived by his wife, three daughters and three grandchildren. He lived here since 1913.

The petitioners asked that sufficient fire hydrants be installed, that a truck and hose carts be stationed in the vicinity, and that fire alarm boxes or necessary telephone connections be provided for at the earliest possible date.

Tests for Dam Being Made In Lomita Hills

Test pits are being sunk in the Palos Verdes hills near Narbonne avenue for the purpose of establishing a site for the storage of aqueduct water, according to Charles Bissell, office engineer for the Metropolitan water district. The pits are being dug in the district engineers' search for a proper anchorage for a dam, Bissell said.

A cross feed pipeline from the aqueduct will end in the vicinity. Aqueduct storage will be necessary should the line be cut off for a day or two. The line will serve Torrance, Compton and Long Beach. Should the dam be established, it might cause the routing of the end of Narbonne avenue because the most likely spot in the hills so far is the canyon thru which that artery runs, according to workmen engaged in making the tests.

Bissell is quoted as saying that to establish the reservoir in that canyon would call for a great deal of legal work and that testing definite has been decided as to the final location of the reservoir.

Meanwhile, oil scouts are also probing the Palos Verdes in the same area. The majority of the land in this district is under lease to the major companies.

The large concerns, as usual, are believed to have their eyes on the modest wildcat project of V. Claren, who is rumored to be casting at 1800 feet in his well near Rolling Hills road, in the Watteria district. Claren said yesterday that he had cemented off in 60 feet of good oil sand. This is the second reaming, since a previously said casing was too small, the derrick being a Columbia Steel worker.

Explains Moneta Water Service

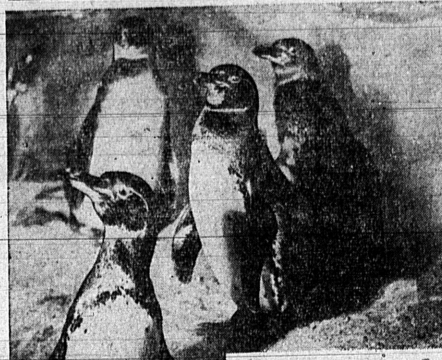
Explaining that the Moneta Water Company is a chartered mutual concern and not a public utility, L. F. Stephenson, secretary-treasurer of the company, said late last week that the only way it can serve residents in North Torrance is for them to buy a share of the stock of the city of Torrance approach the Moneta stockholders with the same intentions.

"Because we are not a utility, merely a mutual group desirous of obtaining water from a central source, we are not subject to the customary 'demands' for water connections," Stephenson pointed out. "However, if the city wants to aid residents in North Torrance, we would be most happy to enter into negotiations relative to participation in our non-profit company."

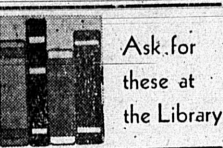
This would mean, the Moneta executive pointed out, that the city should purchase some stock (become members of the mutual concern) and then lay pipelines to serve the North Torrance people who appeared before the council meeting March 23. Stephenson said the Moneta concern had an ample supply of water "enough to serve the whole city of Torrance, for that matter," because it held the water rights, to tap an underground river of pure aqua that needs no chlorinating treatment.

ROSE DEEPROSE by Sheila Kaye-Smith: In this novel Miss Kaye-Smith has returned to the English South Country, the scene of many of her earlier stories, and her heroine is a vital character like Joanna Goddon and Susan Spray. Rose Deeprose was born to conflict, a daughter of a Kentish farmer, is warm hearted and impulsive with a capacity for tenderness. We watch her life grow through a series of complexities and tragedies until we feel the story might serve as an example of that popular idea "character is destiny." It is a singularly rich and moving book and those who have enjoyed the earlier books of Miss Kaye-Smith will thoroughly enjoy this new story.

CATHERINE D'MEDICI AND THE LAST REVOLUTION by Ralph Roeder: Roeder has done a fine piece of work and fulfills the first duty of history, "to make past actions better known, that men may know more about the future." He not only brings characters and events to life, but weaves them with a master hand into a grand pattern. The colorful, rapidly shifting personal and political life of Catherine de Medici and her court is told with plenty of picturesque detail; the great social movements are as vividly described as personal events. Not for a long time has there been a book which has made us feel so clearly the March of History.

IN THE STEPS OF SAINT PAUL by H. V. Norton: One can eagerly follow this observant, modern pilgrim, who turns back the pages of history and, taking the Epistles of St. Paul as his real guide, shows us the great apostle both as saint and man. Always alert to the details of the near Eastern setting, he portrays a colorful interpretation of the great world against a living background of yesterday and today.

In following St. Paul on his journeys, the author says enough of him to make us feel his devotion and fire; but often in such places as Cyprus or Athens he tells us more of the Greek and Byzantine or Crusading history, local legends and reforms of Kemal as Atatürk.

In his "Steps of the Master," an account of journeys in the Holy Land, Norton has won commendation by distinguished Catholic and Protestant churchmen and his latest book merits equal praise.
