


In between halves the Lomita reserves played for their own entertainment and both rooting sections went into spasms of cheers, courtesy exchanges of yell-leaders and what-not.

ment group is undaunted by "what has happened in the past to attempts at getting this long-needed paving" and intends to present Pacific Electric officials with the city's favorable action and a sheaf of petitions from interested citizens to show that "we mean business this time."

The petitions he referred to read as follows:  
"Whereas, the condition of Cabrillo avenue is unsightly and an eye-sore to the community, and is dangerous, and an ever-present menace to traffic; and  
"Whereas, the continued progress of Torrance is seriously impeded by the condition of said street, and development and advancement is delayed and hindered because of the unpaved portion of said street; and  
"Whereas, these difficulties and disadvantages may be overcome by the removal of the curb in the center of said street, and by the paving of the now unpaved portion belonging to the Pacific Electric Railway;

"Now therefore, we the undersigned residents and/or taxpayers of the city of Torrance, respectfully urge and recommend the city council to commit itself, and to go on record as approving the paving of said Pacific Electric right-of-way on Cabrillo avenue by the city of Torrance; said paving to be done when permission is received from the Pacific Electric company."
