Famous Dancer, Harald Kreutzberg To Appear In L. A.



Harald Kreutzberg, considered the foremost male dancer, since Nijinsky, returns to Pacific Coast following European triumphs, to appear in two concerts at Philharmonic Auditorium, Los Angeles, Friday evening, November 26, and Saturday matinee, November 27, on the Merle Armitage concert series.

Kreutzberg, who will give entirely different programs at each concert, will be seen in Southern California after an absence of several years. During the interim, the artist has won new laurels by concert appearances in European capitals. In Rumania he was the first modern dancer to make a concert appearance. When he opened his American tour in New York, critics hailed him as greater than ever and a record audience cheered and demanded endless encores.
