## Want Chance for Oil Development

The third protest hearing on the proposed new city-wide zoning ordinance held by the city council last night developed two written objections to the creation of a residential district out of property which may see oil development. These protests were filed with others received during the past two hearings and will be considered when the zoning ordinance is given its final polishing before adoption.

A fourth and final protest hearing will be held by the council in two weeks—on Tuesday night, March 8, at 8 o'clock. The two who objected to the tentative ordinance last night were J. R. Richards of Pasadena and the Torrance Oil Development company, and George W. Neill.

Richards was interested in property from Lincoln avenue north and adjoining the city park, while Neill protested restricting the area south of the park on Cabrillo when there is a chance for oil development. Both said they were keenly interested in the deep-sand tests now being conducted in the South Torrance field.

City Engineer Frank Leonard urged the council to create a set-back line of 100 feet south and north of the park and along Arlington avenue. He said such a set-back would not interfere with oil development on the rear of properties facing the park and the street. No leases have been signed or considered as yet for this area, the engineer said.

The council will take these as well as other protests into consideration when the final draft of the zoning ordinance is considered in about a month.
