## Police Set New Record in Making 12 Arrests Here

Local police set something of a record during the past week when they made 12 arrests in four days. Among those who appeared before City Judge Robert Lessing were:

Thomas L. Schloss, 40-year-old WPastor of Redondo Beach, who was found guilty last Thursday of driving while intoxicated. He must pay a \$50 fine by Aug. 13. Schloss was arrested early last month and released to R. N. Herman, bail broker. When he failed to make bond, he was returned to jail by Herman.

Couple Conditionally Released Tasaburo Tanimoto, 36, Bell Japanese farmer, arrested last Friday for being drunk in an auto at Sepulveda and Arlington. He pled guilty, was fined \$25.

Mr. and Mrs. Paul Skaggs, 1422 Elm street, were arrested on warrants charging disturbance of the peace last Friday afternoon. Skaggs, 26, was released on his own recognizance and Monday promised Judge Lessing to keep the peace while the family is being investigated by juvenile authorities. However, Harper was released from custody after the district attorney's office stated that it believed the case against him was weak and would not "stand up in court." The "mystery car" which officers believe caused the two deaths has not been identified.

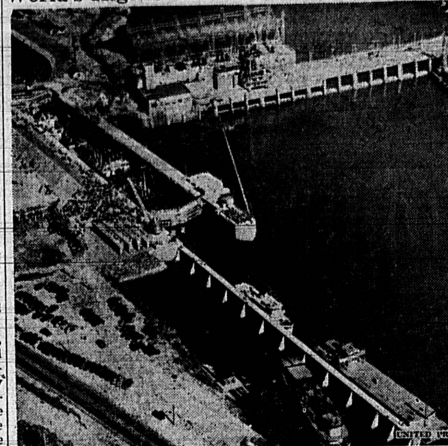

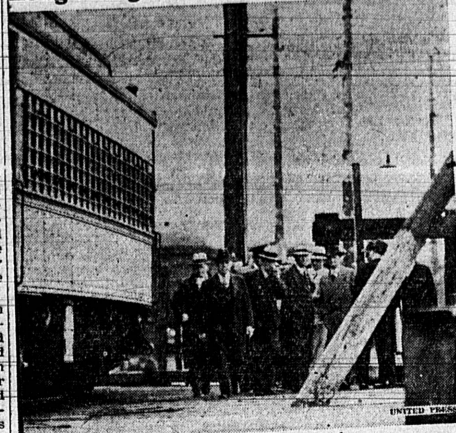
