JUDGE BRIDGE CHAMPIONS HUMAN RIGHTS UNDER LAW

Judge Collamer A. Bridge today declared himself in favor of a "humane administration" of the elementary courts of the county. Judge Bridge, who is a candidate for Justice of the Peace of Inglewood township, office No. 2, pointed out that he preferred to consider the circumstances as well as the technicalities in maintaining justice and civil rights under the law.

Judge Bridge has a long record of public service as well as private practice as an attorney. He is at present municipal judge of Hermosa Beach and has won wide recognition for his juvenile work as well as his personal interest in the welfare of the youth of the community.

He has served in rotation as clerk, president and trustee for 15 years, being returned each time to office by a large vote of the people. A graduate of U. S. C. he has practiced law for the past 25 years.

Tideland Oil Fight Costly, Hatfield Warns

Millions of dollars in oil royalties will be lost, both to the state of California and the city of Long Beach, unless litigation between the city and state over tideland oil wells is immediately settled, Lieutenant Governor J. Hatfield warned today in an open letter to Arlin E. Stockburger, state director of finance.

Pointing out that the huge tideland pool has been valued at \$400,000,000, Hatfield declared that "a speedy compromise of that litigation is absolutely essential, if private interests are to be prevented from draining the tremendous oil pool."

The various suits involving the state, the cities of Long Beach and Los Angeles and private interests, may require years to adjudicate, Hatfield declared, and meanwhile an increasing number of private wells are being put down, rapidly draining the oil not only from under privately owned lands but also from under the public tidelands.
