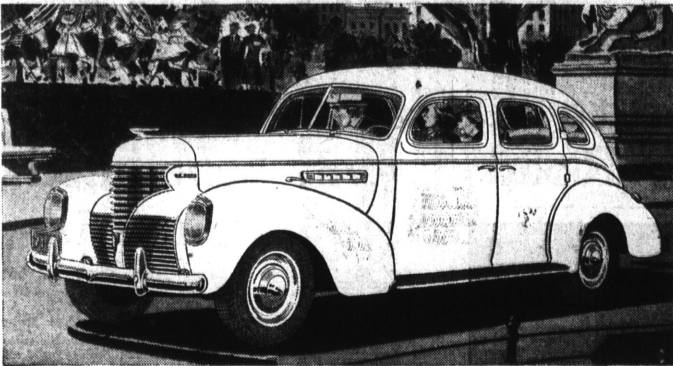

Husband Held for Attempt to Slay Wife

to locate it, have not found the gun.

Aided by Nurse
Last Thursday morning, after obtaining his first job in months, Hunt took his estranged wife for a ride. Parked in the sand dunes of Torrance Beach, he asked for a reconciliation which was refused, according to Mrs. Hunt. Then, he said he told his wife: "I'll fix you so no one will want you." His first shot hit her in the left hip and as she fell out of the car, a second bullet struck her right temple, fracturing her skull and came out near her nose.

Spectators to part of the shooting were Mr. and Mrs. Albert O. DeBord of Inglewood, who were bound for a picnic with seven school children. They heard the first shot and saw Mrs. Hunt dive out of the car. But the DeBords were waved away by the man with her and did not approach to discover what was wrong.

Mr. and Mrs. Wallace W. Kratz of Hermosa Beach were passing the Hunts car at the time of the climax to the reconciliation argument and also heard a shot. Mrs. Kratz, a registered nurse of the Redondo-Hermosa hospital, assisted the injured woman in their car and they drove her to the Redondo police station and then to the hospital. Hunt, they said, drove off without rendering any aid to his wife.

Believed Unbalanced

and said she probably will never again have the use of her right eye. Officer Percy Bennett, who with Police Chief John Stroh, led in the investigation, recounted his conversations with the prisoner.

Police learned that Hunt left the shooting scene and drove to Ocean Park. Enroute, at 4:45 p. m., he ran thru a boulevard stop sign and was given a traffic citation by an Ocean Park motor officer. He went to a friend's house. This friend, Jerry Sipkens, chauffeur for the Veterans' Administration, testified that Hunt demanded liquor and then said he "beat up my wife." Sipkens stated, in answer to questions from Attorney Sherwin, that he believed Hunt to be mentally unbalanced.

Hunt was lead over the scene of the assault Friday by local police in quest of the revolver. Later city firemen burned over much of the terrain but neither that nor the use of a magnetic compass by Gene DeBra failed to reveal the weapon. The state was represented at the hearing by S. E. Roll, deputy district attorney.

Christian Scientists Hold Annual Meeting This Week in Boston

BOSTON, Mass., June 5—Thousands of Christian Scientists, meeting in this city this week, challenged a troubled world to change its perspective from a material to a spiritual basis in its search for release from pressing economic and political problems.

The occasion for the great influx of the followers of Mary Baker Eddy was the annual meeting of The Mother Church, The First Church of Christ, Scientist.

Announcement of new officers constituted the main business of the meeting. George Shaw Cook, C.S.B., of Brookline, Mass., was named President for the ensuing year to succeed Ralph H. Knapp of Needham. Edward L. Ripley

of Brookline and Ezra W. Palmer of Marshfield were re-elected Treasurer and Clerk, respectively. The President is elected by The Christian Science Board of Directors for a one-year term, his chief duty being to serve as presiding officer at the Annual Meeting.

Cook is a native of Iowa, moving to Chicago at an early age where he received his public school education. Entering the commercial world he became a partner in a firm dealing in investment securities. He became interested in Christian Science in 1895, served as First Reader of Fifth Church of Christ, Scientist, Chicago, and served successively thereafter as Committee on Publication for Illinois.
