

Streets Re-surfaced at Small Cost Here

County's Growth May Reach Three Million in 1940

Superintendent Says Crowns Becoming Hard

Motorists driving over this city's recently resurfaced streets on warm afternoons have become accustomed to the swish-swish of their tires rolling over the semi-fluid oil that "bleeds" with hot weather.

Pedestrians crossing streets have gotten many a shoe-ful of the gravel that worked down to the curbs from off the crown of the improved avenues.

Both motorists and pedestrians have, on various and sundry occasions, asserted that the re-surfacing job was poorly done. But that is a distinctly erroneous conclusion.

Used State Specifications. It won't be long, says William "Andy" Gascoigne, veteran street superintendent, until the improved streets will stop "bleeding" oil on warm days. Furthermore, the excess gravel has been removed entirely now and will no longer have to be shoveled back to the crowns.

Periodic shoveling of the excess gravel back on the crown of the streets resulted in building up hard surface that will last for years without cracking, the street superintendent points out.

And Gascoigne points out that the rock and oil mix was laid according to tested and approved state specifications.

"We completed the first part of a general street improvement program at a cost of about one-half cent per square foot of re-surfacing," Gascoigne said. "If we had laid 'hot-stuff' on the streets, the cost would have been six times as great—or about three cents a foot."

Wants More Equipment. "This was a real saving" by following the state specifications were able to resurface more streets so far this year than any time in the past. However, we are not thru yet. The city street department is watching the laying of a new type of pavement, using a hot asphalt formula, in Compton and we may try out that mix here on a residential street."

Gascoigne, like other municipal department heads, has submitted a list of his equipment needs to the council while that body is wrestling with the city budget for 1939-40. Tires among his desires is a street sweeper and cleaner. Whether or not he'll get this and several other pieces of equipment which he says are badly needed to enable his department to function efficiently is a moot question.
