## **New Court to Hear Marital** Difficulties

Marital difficulties of couples with children hereafter may have their first hearing in the Children's Court of Conciliation of Los Angeles county, authorized this week when Governor Culbert Olson signed the bill sponsored by Superior Judge Ben B. Lindsey, internationally known authority on divorce and juvenile problems.

When a divorce or separation is impending in a family where there are children, either husband or wife may file a prepetition in the new court, and a hearing will be set before a conciliator.

The conciliator, who is to receive \$4200 a year, may be aided by psychiatrists, doctors, pastors and attorneys. Judge Ljndsey believes that reconciliations will result in many cases and that many others will be settled by agreement, at a large saving to the taxpayers.
