## Lomita Youth Held After Crash

A 17-year-old Lomita schoolboy was charged with embezzlement as the aftermath of an automobile accident at El Prado and Sartori avenue early Saturday morning. The boy was accused by Stanley Pavlitski of Lomita of taking the latter's car without the owner's permission.

At the time of the accident, police reported that Cutin Rodriguez of 2401 Pennsylvania avenue, Lomita, was driving Pavlitski's machine. Rodriguez, who was accompanied by a 15-year-old Lomita schoolboy and the 17-year-old youth, collided with or was struck by another car driven east on El Prado by Harold Clayton, 19, of 1221 El Prado.

Pavlitski, summoned by police, promptly asked for a warrant charging the young Lomitan with embezzlement. The boy was later certified to the juvenile court and was released on his own recognizance to his mother. Both machines were said to have been badly damaged.

The fire department was called to wash off the street in the vicinity of the accident to remove danger of fire from the spilled gasoline.

AN ORDINANCE OF THE CITY OF TORRANCE PROVIDING FOR THE PROTECTION OF LIFE AND PROPERTY FROM FIRE AND CREATING AND ESTABLISHING FIRE ZONES.  
The City Council of the City of Torrance ordains as follows:  
The City of Torrance shall be and the same is hereby divided into Fire Zones, designated and described as follows:

SECTION I. FIRE ZONE NUMBER ONE shall include all that portion of the City of Torrance described as follows:  
Blocks 1, 2, 5, 6, 7, 8, 17 and Lots 1 to 14 inclusive in block 9 of Torrance Tract.

SECTION II. FIRE ZONE NUMBER TWO shall include all that portion of the City of Torrance described as follows:  
Lots 6 to 9 inclusive and Lots 31 to 33 inclusive of Tract No. 1884.

Lots 1 to 5 inclusive and Lots 10 to 30 inclusive, Block 3, Torrance Tract.

All of Blocks 4, 18 and 71, Torrance Tract.

Lots 15 to 25 inclusive, Block 9, Torrance Tract.

Lots 1 to 8 inclusive, Block 13, Torrance Tract.

Lots 1 to 6 inclusive, Block 14, Torrance Tract.

Lots 1, 2, 3, 20, 21, 22 and vacated portion of alley in Block 15, Torrance Tract.

Lots 1 to 8 inclusive, Block 16, Torrance Tract.

Lots 1 to 5 inclusive, Block 17, Torrance Tract.

SECTION III. FIRE ZONE NUMBER THREE shall comprise all that portion of the City of Torrance not included within Fire Zones No. 1 and No. 2.

SECTION IV. The City Council may, by resolution, change the boundaries of any of the Fire Zones described herein.

SECTION V. The City Clerk of the City of Torrance shall certify to the passage and adoption of this Ordinance and cause the same to be published once in the Torrance Herald, a weekly
