### New Type Rail Brake Uses Auto Principle

PHILADELPHIA (U.P.) — A new type railroad brake which will stop trains within 2,500 to 3,000 feet from 100 miles an hour—about half the distance now required—has been developed.

The brake eliminates the principle of a metal "shoe" pressing against the rim or tread of the wheel, it is explained. Instead, the brake is fashioned similarly to automobile brakes. A composition shoe exerts pressure on an air-cooled disc or drum mounted on the axle inside the wheel. Fan-like discs cool the brake to prevent extreme heat.
