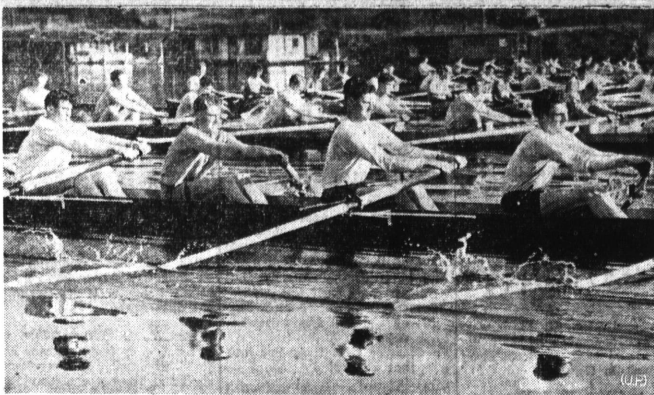

Easter Sunday, March 24: High Mass at 8 a. m. Low Mass at 10 o'clock followed by Benediction of the Blessed Sacrament.

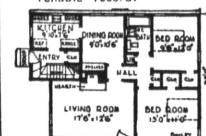
