

County Asked Not to Charge Patients in Isolated Ward

County supervisors have been asked to order discontinued the practice of the county hospital in billing patients in its communicable disease wards on the grounds that this is a step to

discourage isolation of communicable disease cases. The Los Angeles County Chapter of the National Foundation for Infantile Paralysis has filed the request with the board. The chapter asserts that billing of these patients tends to increase the tendency for persons afflicted with communicable diseases to elect to remain at home rather than enter these isolation units at the hospital.
