## ORDINANCE NO. 317

AN ORDINANCE AMENDING PARAGRAPH 72 OF SECTION 12 OF ORDINANCE NO. 235 OF THE CITY OF TORRANCE, ENTITLED "AN ORDINANCE PROVIDING FOR LICENSING AND REGULATING THE CARRYING ON OF CERTAIN PROFESSIONS, TRADES, CALLINGS AND OCCUPATIONS CARRIED ON WITHIN THE LIMITS OF THE CITY OF TORRANCE, REPEALING ORDINANCES NO. 110, NO. 126, NO. 137, NO. 151, NO. 183, NO. 196, NO. 211, AND ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF."

The City Council of the City of Torrance does ordain as follows:

SECTION 1. That Paragraph 72 of Section 12 of Ordinance No. 235 of said City of Torrance, entitled "An Ordinance Providing for Licensing and Regulating the Carrying on of Certain Professions, Trades, Callings and Occupations Carried on Within the Limits of the City of Torrance," Repealing Ordinances No. 110, No. 126, No. 137, No. 151, No. 183, No. 196, No. 211, and all Ordinances or Parts of Ordinances in Conflict Therewith, and Providing Penalties for the Violation Thereof, be and the same is hereby amended to read as follows:

"72. For every person, firm or corporation engaged in soliciting or canvassing, \$5.00 per day. All orders taken by licensed solicitors or canvassers shall be in writing, in duplicate, stating terms thereof, and one copy shall be given to the purchaser."

Every solicitor, canvasser, or peddler, as defined in this Section, desiring a license shall make application to the City Clerk, stating the kind and price of goods offered for sale or kind and cost of service to be performed; such application shall be accompanied by a bond in the sum of \$500.00 in cash or executed by a surety company or by two responsible freeholders residing in the City of Torrance, conditioned upon the final delivery of the goods ordered or full and proper performance of the services to be performed, in accordance with the terms of such order, or failing therein that advance payment, if any, on such order be refunded. Such bond shall remain in full force and effect for a period of 90 days

after the expiration of any such license, unless sooner released by the Council.

Each and every license issued under the provisions of this Section shall not be transferable and shall be for the exclusive use of the person whose name is inserted therein. Such person shall be required to write his name on the margin of such license and on the stub retained by the Clerk at the time such license is issued. Such person shall be required to furnish to the Clerk at the time of application for such license two copies of a photograph of himself. It shall be and hereby is made the duty of the Clerk to satisfy himself by proper examination and investigation that the same photograph is a true likeness of the person who makes the application and whose name appears thereon. One copy of said photograph shall be attached to the license and the other shall be attached to the stub retained by the Clerk. The photograph shall at all times be kept attached to the license and any license found without such photograph attached thereto shall be taken up and be forfeited, and the person to whom said license is issued and the holder thereof shall forthwith surrender such license and shall not again be entitled to any license.

If all conditions of this ordinance are properly met by an applicant for a license to solicit, canvass or peddle animate or inanimate objects on foot or by vehicle in or about the limits of the City of Torrance, the said applicant shall be referred to the Chief of Police of the City of Torrance who shall thereupon take fingerprints and make other such necessary identification record of the applicant. The Chief of Police of the City of Torrance shall thereupon conduct an investigation of said applicant and approve or disapprove the application within the period of 48 hours but in not less than 24 hours following application to the City Clerk of the City of Torrance. If approved, the City Clerk shall thereupon issue said license.

Such person shall identify himself by his signature and or fingerprints whenever required to do so by any police officer or representative of the City Clerk's office of the City of Torrance. Should any such license be found in the possession of any person other than the person named therein, it shall be taken up, surrendered to the Clerk and canceled, and the holder thereof shall not again be entitled to a license under this Section.

Whenever the holder of any license uses any wagon, cart, tray, basket or other vehicle or receptacle in vending any goods, wares or merchandise, such license shall be inserted, held and carried in a license holder in a conspicuous place in or on said vehicle or receptacle.

Provided all other provisions and conditions of this ordinance relating to solicitors, canvassers and peddlers are complied with, every honorably discharged soldier, sailor or marine who is unable to obtain his livelihood by manual labor shall have the right to peddle and or vend any goods, wares or merchandise except spirituous, malt, vinous, mixed or other intoxicating liquors without payment of any license or fees required by this Code or ordinance of this City providing for the payment of such license fee. A certificate of disability by a surgeon of the United States Army or Navy, or by the Director of the Los Angeles County Health Center located in the City of Torrance, or by any registered physician regularly established and doing business within the City of Torrance, shall be sufficient proof of such disability. A certificate of honorable discharge from the United States Army or Navy, or an exemplified copy thereof, shall be sufficient proof of such service and honorable discharge, and upon presentation of the same it shall be the duty of the Clerk to record this fact upon the application of the honorably discharged soldier, sailor or marine, and if approved by the Chief of Police, it shall be the duty of the Clerk to issue a license with out cost to such soldier, sailor or marine.

Every license issued under the provisions of this Section shall be issued for a period of one year from date of issuance thereof. Upon expiration of any license as herein provided a new license shall be issued under the provisions of this Section. Not more than one license shall be issued to any discharged soldier, sailor or marine during any one calendar year from the date of the original license.

No person except the person named in such license shall use or have in his possession any license issued under the provisions of this Section. No person shall sell, purchase or transfer any license issued under the provisions of this Section, or trans-

fer or convey the discharge or certificate mentioned herein to any other person for the purpose of securing the license herein provided for.

None of the provisions for the licensing of solicitors, canvassers and peddlers shall be deemed to apply to those established firms or corporations regularly doing business within the County of Los Angeles and the State of California who have heretofore been granted license under the provisions of Section 12, Paragraph 14 of said Ordinance No. 235 to solicit orders for merchandise deliverable from their established places of business; provided that license fees are paid on the annual basis as set forth in said Section and Paragraph.

SECTION 2. That all Ordinances and parts of Ordinances in conflict herewith be, and the same are hereby repealed.

SECTION 3. The City Clerk of the City of Torrance shall certify to the passage and adoption of this Ordinance and shall cause the same to be published by one insertion in the Torrance Herald, a weekly newspaper printed, published and circulated in said City, and thirty days thereafter it shall take effect and be in full force.
