NEW STEEL HEAD ... Irving Sands Olds, newly-elected chairman of the board of the U. S. Steel Corporation is a native of Pennsylvania, graduate of Yale and Harvard and former secretary to the late Justice Holmes of the U. S. Supreme Court.

During 1917-1919, Olds served as counsel for the Purchasing department of the British War Mission to United States, and in 1918 was a special assistant in the U. S. War Department. Since 1919 he has engaged in legal work related to matters of organization and administration of corporate business enterprises.

He has been a director and member of the Finance committee of the steel corporation since October, 1936 and was elected Chairman of the Board June 4, 1940 to succeed Edward R. Stettinius, Jr., who resigned to serve as a member of the National Defense Commission.

Slough Area May Be Retarding Basin for Floods

Study of a proposal to create what would amount to another "flood control retarding basin" in the old Nigger Slough area now known as Laguna Dominguez was being made today by flood control engineers, following its presentation to the board of supervisors Tuesday.

While the dam would cause flooding of 320 acres in the northern part of the swamp, it would permit the reclaiming of 816 acres lying below it for industrial and similar heavy uses, the board was told by J. A. Benell and H. H. Jarrett, representing the Dominguez Estate. Water impounded behind the dam following storms would drain out slowly during the summer months and make a desirable refuge for wild life, as has been suggested by the Audubon Society. Cost of a low earth-fill dam just below the junction of Broadway and Main streets to create the artificial lake is estimated at \$75,000.

The supervisors took preliminary steps to prevent dwellings from being built in the low-lying areas of Laguna Dominguez and Johnson Lake by instructing County Counsel J. H. O'Connor to draft an ordinance to prohibit residences and buildings for public assembly below a point 15.5 above sea level.

Area included in the ordinance is bounded roughly by Normandie avenue, Avalon boulevard, 182nd street and Carson street, known as Laguna Dominguez. The Johnson Lake area, adjacent to Strawberry Park, is northerly of Gardena and here houses and public assembly buildings would be prohibited below 47.5 feet above sea level.

Several Thousand Lots Go On Block at Tax Sale Auction July 1

For the first time since 1934, tax-delinquent property will be offered for sale at public auction July 1 at the office of County Tax Collector H. L. Byram, it was announced today.

Local residents may actually bid on this property for the first time in five years due to removal of the moratorium on sale of tax-delinquent holdings, of which there will be several thousand parcels of all kinds.

Acreage, subdivided lots, a few of them improved with cabins and dwellings, are included in Byram's list. The sale is to begin at 9 a. m. at Byram's office on the third floor of the Hall of Justice.

No bids will be accepted for less than the amount of all taxes, penalties and costs due as shown in the advertised list, Byram said. After a bid has been accepted, the right of redemption shall cease, except as to the purchaser, who shall have 30 days to redeem on the balance of the taxes due. In other words, the buyer need not put down the full amount at time of purchase.

Colden Headquarters Burglarized; No Clues to Marauders

No clues yet have been found to the identity of the person or persons who burglarized the Southwest campaign headquarters of Mrs. Clara N. Colden, Congressional candidate, at 7210 1/2 South Vermont avenue, it was stated today by Joseph C. Huston, headquarters manager. Report of the burglary was made by Huston Tuesday morning to police of the 77th Street station.

According to Huston, several precinct maps, a list of more

than 150 names of precinct workers, all of the files and other campaign organization records, which had taken three months' work to compile, were stolen. Entrance to the headquarters was effected, it was stated, by removing part of a window at the rear of the room and then lifting the bar of the door. Discovery of the robbery was made by Huston when he opened the office Tuesday morning.

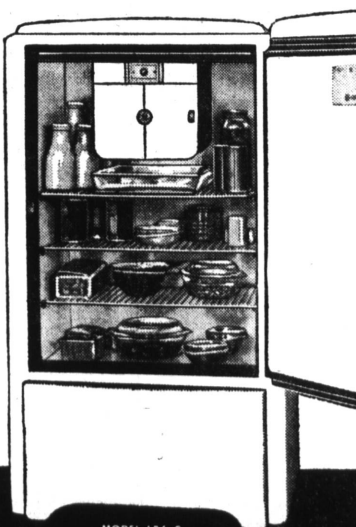
