Francis Parkinson Keyes' "GREAT TRADITION" is the story of "today at war with yesterday." It is a dramatic, timely story of a young man's struggle to find a way of life and of love amid dynamic forces of modern Europe. Hans, an American youth whose grandparents represent two conflicting but equally great traditions, visits Germany in the days after the war. He watches with horror while one tradition crumbles, and glows with new hope as the other takes up the challenge. The scenes are in Germany, America and Spain, and the dual love story, poignant and tense, will capture reader's interest.

LET THE PEOPLE SING by J. B. Priestly: At last we have a gallant successor to "Good Companions" and an amusing story. Two innocent fugitives from British law join forces with a traveling show and auction. One of these is Timmy Tiverton, an old music-hall comedian down on his luck who has been mistaken for an I. R. A. bomb thrower. The other is a professor from Prague who is having trouble with his passport. These oddly assorted companions, after other adventures come to a small English town, Dunbury, where a dispute is raging as to who shall have the use of the Market hall. Here the extravaganza becomes fast and furious. It is a cheerful nonsensical story but with considerable social significance in the sentiment of confidence in the common people and in the power they have to take their right to their own kind of happiness.

AN OLD CAPTIVITY by Nevill Shute: He was an aviator flying an arctic expedition single-handed. She was a headstrong girl and the daughter of the man who employed him. The flight was hard-flying, thru blinding fog, battling with ice and snow. After the desperate flight was over came a dream, and we live in two worlds: the great adventure of Lief Ericson, with its vision of America, becomes interwoven with the modern tale. On this romantic framework is built a romance that has great charm.

CAPITAL CITY by Marie Sandor: The author is roused by the same hatred of greed which was expressed in her "Slogum House" to blaze away against the selfishness of a smug parasitical community in "Capital City." The story is a violent one and unre-

## Motorists Will Pay Share for Defense in Increased Taxes

Increases in Federal automotive taxes enacted to help finance the national defense program became effective July 1.

The raise in rates and continuation of the Federal automotive taxes were enacted by Congress for a five-year period. The automobile excise tax is payable by automobile manufacturers on their price to dealers. It is presumed that this tax will be added to the retail sales price of new cars and equipment affected. The old and new rates are as follows:

## State Primary On Aug. 27 Has Many Candidates

SACRAMENTO (U.P.)—A total of 509 persons qualified for the Aug. 27 primary ballot, Secretary of State Paul Peek announced this week.

Eight men will contest for the United States senate now held by Hiram Johnson, 112 candidates filed for congress, 48 for the 20 state senate seats and 341 for 80 assembly posts.

All of the state's 20 congressmen sought reelection with the exception of the late Thomas Eator of Long Beach, whose post was contested by 13 candidates. Only Harry Englebright of Nevada City escaped opposition among the incumbent representatives. Thirteen incumbents among the 20 senatorships to be filled filed for reelection and 66 of the 80 assemblymen.
