## Public Hearings On Co. Budget Start June 11

Next Thursday, June 11, will mark the opening of public hearings on the 1942-43 county budget. Printed copies of the new budget are now available at the Hall of Records for any taxpayer interested.

For 10 days, members of the board of supervisors will listen to any taxpayer or taxpayers group that wants to be heard with regard to any item or portion of the budget. Items may be decreased, but not increased in the final budget as compared with the preliminary. The preliminary budget calls for \$79,180,000 for general county government, exploitation, retirement of bonds, salaries and wages, which is believed to be too high to be under last year's general county tax rate of \$1.4627.

However, no indication has been given as yet as to what the total assessed valuation of the county will be. It is believed by many that it will be higher on account of the large amount of new building, but on the other hand the valuation on large downtown office buildings is going down and it takes a number of new houses to offset the loss on one of these downtown properties.

## State to Compensate Injured Municipal Workers in Emergency

In rescinding its previous decision of not assuming responsibility in case of City Engineer Glenn Jain vs. a Civic Auditorium wall in which the engineer's nose came off second best and bruised during the Feb. 24 blackout, the State Compensation Insurance Fund notified the city council at last meeting that it was assuming Jain's \$2 medical bill. Thus the Fund admitted liability in case of injury to city employees doing extra duty during emergencies.

City Attorney John McCall reported that a bill is now before Congress which will insure qualified Civilian Defense workers such as Air Raid Wardens, Auxiliary Police and Firemen, against mishaps during blackouts. On motion by Councilman Vern Babcock, City Clerk A. H. Bartlett was instructed to write the California senators and congressmen urging favorable action on this measure.

**FOR POST-WAR FAIR** Although the Army has taken over the state fair grounds at Sacramento, for the duration, considerable maintenance work is continuing to have all in readiness when the largest state fair in the U.S. reopens after the war.

**FUNDS LIMITED** The state highway commission has indicated that funds for only the most vital highway construction and repair of defense-used highways will be available for the rest of the present fiscal year.

**ENLIST EVERYONE** Warnings that "every man, woman and child available for farm labor must be enlisted" coupled with recommendations that all district and county fairs supported by state parimutuel money be discontinued have been made by the state board of agriculture.

## Month's Building Totals \$27,480

Restrictions in the form of priorities and "frozen" floors put a major crimp in the city's building last month. New construction here totaled only \$27,480 as compared to \$48,110 during May 1941. However, the total in building permits for the year to date is still well ahead of the total for the first five months of 1941—\$326,692 as compared to \$152,982 last year.

Four new homes were erected in Torrance last month at a cost of \$8,900. Other construction included four garages, \$1,000; one tank, barn, sign, factory building, \$13,450, and alteration and repair jobs totalling \$4,130.


